## **ORDINANCE NO. 90-027**

AN ORDINANCE REQUIRING EACH BUSINESS ESTABLISHMENT SITUATED IN THE CENTRAL BUSINESS DISTRICT TO PROVIDE ONE TRASH CAN EACH YEAR TO BE PLACED INFRONT OF SAID ESTABLISHMENT OR IN DESIGNATED AREAS AS DEEMED NECESSARY AND PROVIDING PENALTY FOR VIOLATION THEREOF: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** - TITLE OF THE ORDINANCE. - This ordinance shall be known as "A CAN FOR CLEANLINESS OF 1990".

**SECTION 2.** - SCOPE OF ORDINANCE. - this ordinance shall cover each business establishment situated in the Central business District (CBD) of the City of Naga in order to assure the full implementation of the cleanliness program of the City in partnership with the business sector.

## **SECTION 3.** - DEFINITION OF TERMS. - As used in this ordinance.

- a) <u>BUSINESS ESTABLISHMENT</u> shall refer to any single proprietorship, partnership, corporation or cooperative that conduct business on the ground floor of any building or structure along the principal streets in the Central business district (CBD) whose occupied space has a floor area of not less than 20 square meters or with a gross sales for the preceding calendar year of not lower than P50, 000.00. This will include, but not limited to groceries, super mart, hardware, restaurants, poultry, drugstore, department store, bank, theaters, bakery, etc. Stallholders in the Naga City Public Market shall be covered by a separate ordinance.
- b) <u>PRINCIPAL STREETS</u> shall include the streets or portion thereof situated within the Central business District (CBD) delineated by P. Burgos St., on the North from Hernandez avenue, towards east up to the Naga River; on the East and on the South by the Naga river; on the West by the Hernandez Avenue from the Naga River bank towards north up to corner P. Burgos St., as follows:
  - a. P. Burgos St.
  - b. Elias Angeles St.
  - c. Penafrancia Avenue
  - d. Panganiban Drive

- e. General Luna St.
- f. Evangelista St.
- g. Abella St.
- h. Hernandez Ave.
- i. Prieto St.
- j. Padian St.
- k. Dinaga St.
- I. General Luna St., back alley
- C. <u>TRASH CAN</u> a drum cut into half with handle and cover painted with the name of the business establishment giving it.

**SECTION 4.** - (a) It shall be required of business establishments situated in the city's CBD to provide one (1) trash can each every year to be placed infront of the establishment or at designated areas as deemed necessary in the said district that may be determined by the city government;

b. That the City Planning and Development Office under the Office of the City mayor shall promulgate the implementing rules and guidelines of this ordinance in order to assure its smooth implementation with prior consultation with the establishments concerned.

**SECTION 5.** - Any violation of the provision of this ordinance shall be penalized with a fine of Five Hundred (P500.00) Pesos payable to the City Treasurer's Office.

**SECTION 6.** - SEPARABILITY CLAUSE. - If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, the remainder of this ordinance, and the application of such provisions to other provisions to other persons or circumstances shall not be affected thereby.

**SECTION 7.** REPEALING/AMENDATORY CLAUSE. - All ordinances, rules and regulations or portions thereof, inconsistent with this ordinance are hereby repealed, amended and/or modified accordingly.

**SECTION 8.** - EFFECTIVITY. - This ordinance shall take effect one (1) month after its approval.
