## ORDINANCE NO. 91-011

## AN ORDINANCE PROHIBITING THE DRIVING, USE, OR OPERATION, WHETHER FOR HIRE OR FOR PRIVATE SERVICE, OF ANY PADYAK AND BICYCLE WITHIN THE CITY OF NAGA DURING NIGHT TIME WITHOUT THE PROPER LIGHTING DEVICES INSTALLED ON SAID VEHICLES AND IMPOSING PENALTIES FOR VIOLATION THEREOF:

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1**. - It shall be unlawful for any person to drive, to use or to operate, whether for hire or for private service, any "padyak" and bicycle within the City of Naga during night time without the proper lighting devices installed on said vehicles;

**SECTION 2.** - For padyak, there shall be two (2) lights bulbs generated by any advice, one bulb placed on the front side of the bicycle and the other on the right side of the sidecar, and a reflectorized device installed at the back;

**SECTION 3.** - For bicycles, one (1) light bulb placed on the front side of said bicycle and a reflectorized device installed at the back;

**SECTION 4.** - PENALTY. - Any person violating the provisions of this ordinance shall be penalized by a fine of:

- (a) One Hundred (P100.00) Pesos for the first offense and impounding of the unit at the PNP Station for five (5) days;
- (b) Two Hundred (P200.00) Pesos for the second offense and impounding of the unit at the City PNP Station for ten days;
- (c) Three Hundred (P300.00) Pesos and imprisonment of not more than sixty (60) days for the third and succeeding offense at the discretion of the court.

**SECTION 5.** - The City PNP Command shall maintain a separate Log Book for recording all violations of this ordinance;

**SECTION 6.** – Ordinances, regulations, or parts thereof which are inconsistent with this ordinance are hereby repealed or amended accordingly;

**SECTION 7.** – This ordinance shall take effect fifteen (15) days from its approval.
