ORDINANCE NO. 91-021

AN ORDINANCE RE-ENACTING ORDINANCE NO. 192, SERIES OF 1958 ENTITLED: "AN ORDINANCE PROHIBITING THE ROAMING, LOITERING OR SLEEPING OR UNCHAPERONED CHILDREN BELOW EIGHTEEN (18) YEARS OF AGE AT LATE HOURS OF THE EVEN9ING OUTSIDE THEIR DOMICILE AND PROVIDING PENALTIES THEREOF", WITH AMENDMENTS TO ITS SECTION 6 ON PENALTY: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. – Ordinance No. 192, Series of 1958 entitled: "Ordinance prohibiting the roaming, loitering or sleeping of unchaperoned children below eighteen (18) years of age at late hours of the evening outside their domicile and providing penalties thereof" is hereby re-enacted with amendments to its Section 6 on Penalty, and to its Section 7 on Effectivity, as follows:

"SECTION 1. – Any parent, guardian or person in charge of the custody and care of any child below EIGHTEEN (18) years of age is hereby enjoined from allowing such child to roam, loiter or sleep in any street, park, plaza or sidewalk of any building in the City of Naga between ten (10:00) o'clock in the evening and four (4:00) o'clock in the morning;"

"SECTION 2. – Parents, guardian or persons in charge of the custody of minors due to negligence, inadvertence or lack of parental attention results in such child's roaming, loitering or sleeping in such places mentioned in the preceding section shall be held responsible and be penalized as hereinafter provided for";

"SECTION 3. – For purpose of this ordinance, children who are out in the street, during the prohibited period for a purpose of selling newspaper, or foodstuffs or do errands at the instance of their parents, relatives or guardians shall be exempted from this Ordinance; PROVIDED that such child shall be provided with a written and signed certificate by the person or parents who allow such children to go out at night during the prohibited hours in legitimate purposes or errands; PROVIDED FURTHER, that such child pr children shall not loiter after performing their errands or through with their usual occupation or calling; and children who are accompanied by their parents guardians, relatives and those who are emancipated by way of marriage, or by voluntary concession are likewise exempted from this ordinance;"

"SECTION 4. – This ordinance is temporarily suspended during every feast days and or legal holidays of each year";

"SECTION 5. – Any child or children violating any provisions of this ordinance shall be confined in the City Detention Cell on the night he/she is arrested and shall be released on the following morning";

"SECTION 6. – PENALTY. – Any parent, guardian or person in charge of the custody of minors who violated this ordinance shall be penalized with a fine of not less than Fifty (P50.00) Pesos but not more than Two Hundred (P200.00) Pesos or an imprisonment of not less than Ten (10) days but not more than Fifteen (15) days or both such fine and imprisonment at the discretion of the Court".

SECTION 2. – SECTION 7 of said Ordinance No. 192 is hereby repealed.

SECTION 3. – This ordinance shall take effect immediately upon its approval.
