ORDINANCE NO. 93-027

AN ORDINANCE REQUIRING ALL TRUCK OPERATIONS DOING BUSINESS IN THE CITY OF NAGA TO REGISTER IN THE OFFICE OF THE CITY TREASURER THE VOLUMENTRIC CAPACITY WITH RED PAINT ON BOTH SIDES OF THE VEHICLES:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - TITLE. - An ordinance requiring all truck operators doing business in the City of Naga to register in the Office of the City Treasurer the Volumentric Capacity of their vehicles; length, width and thickness and write such data in red paint on both sides of the vehicles.

SECTION 2. – DEFINITIONS. -

1. Truck is a vehicle, six-wheeler or more used to convey concrete aggregates, earthfill and the like from known sources to destination.
2. Volumentric capacity is the total volume supposed to be carried by the vehicles by multiplying together the inside dimensions of length, width and thickness expressed in cubic meter only.
3. Truck operator is the owner whose vehicle is registered in his name doing business in the City of Naga.

SECTION 3. - PROHIBITIONS. - It is strictly prohibited for truck owners or truck operators to operate a trucking business in Naga City without complying with the above-stated requirement.

SECTION 4. – PENALTY. - Any truck operator or truck owner found guilty of violation of the provision of this Ordinance by any court of competent jurisdiction shall be penalized with:

1. A fine of not less than P100.00 nor more than P300.00 for the first offense;
2. An imprisonment of not less than 10 days nor more than one month and the vehicle will be impounded;
3. Both fine and imprisonment at the discretion of the court with the vehicle to be impounded at the City Hall grounds.

SECTION 5. - SEPARABILITY CLAUSE. - If for any reason any provision of this Ordinance shall be held unconstitutional or not valid by any court of competent jurisdiction such judgment shall not affect or impair the other provision or a part thereof which shall continue to be in force or on effect.

SECTION 6. - REPEALING AND AMENDATORY CLAUSE. - All ordinances, rules and regulations or any part thereof which are in conflict or inconsistent with the provision of this Ordinance are hereby repealed and/or modified accordingly.

SECTION 7. – EFFECTIVITY. - This ordinance shall take effect thirty (30) days after approval.
