## ORDINANCE NO. 93-051

## AN ORDINANCE AMENDING SECTION 4 OF ORDINANCE 412, SERIES OF 1973, OTHERWISE KNOWN AS AN ORDINANCE PROHIBITING CERTAIN ACTS IN PUBLIC PLACES: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** - Section 4 of Ordinance No. 412, Series of 1973, is hereby amended, now to read as follows:

"SECTION 4. - ANY PERSON OR PERSONS found guilty or violating any provision of this ordinance shall be fined the amount of not less than Two Hundred (P200.00) Pesos nor more than Five Hundred (P500.00) Pesos or shall be imprisoned for not less than two (2) months nor more than six (6) months or both such fine and imprisonment at the discretion of the court".

**SECTION 2.** - For purposes of this ordinance, certain acts that are prohibited include:

- a) putting-up of one's foot at the back of any seat or arm-rest or banister while in movie houses, theaters or auditoriums;
- b) smoking in movie houses, theaters, auditoriums, elevators, air conditioned hospitals.
- c) Spitting on the floor of theaters, moviehouses, auditoriums, public vehicles, elevators, eateries, and other public buildings.
- d) Littering of rubbish in theaters, moviehouses, auditoriums, public vehicles, elevators and other public buildings;
- e) Urinating on the floor of theaters, moviehouses, auditoriums, public vehicles, elevators and other public buildings;
- f) Petting, kissing or committing other indecent acts in movie houses, theaters, auditoriums or public vehicles.

**SECTION 3.** - SEPARABILITY CLAUSE. - If for any reason or reasons, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to be in full force and effect;

**SECTION 4.** - REPEALING AND AMENDATORY CLAUSE. - Any ordinance and administrative regulations or part or parts thereof which are inconsistent with this ordinance, are hereby repealed, amended or modified accordingly;

**SECTION 5.** - EFFECTIVITY CLAUSE. - This ordinance shall take effect upon its approval and after publication in a newspaper of local circulation.
