



ORDINANCE NO. 93-087

AN ORDINANCE REGULATING THE USE OF ELECTRIC WATER BOOSTER PUMPS, REQUIRING WATER SYSTEMS FOR RESIDENTIAL SUBDIVISIONS AND CERTAIN ESTABLISHMENTS AND BUILDINGS, AND PROVIDING PENALTIES FOR VIOLATION THEREOF: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - The installation of electric water booster pumps on connection to Metro Naga Water District (MNWD) distribution lines is hereby prohibited, unless the electric water booster pump shall draw from a water reservoir;

SECTION 2. - In cases where the MNWD cannot as yet supply the water requirements of the following:

- 1. residential subdivisions;
- commercial/industrial establishments and buildings whose water consumption for commercial, industrial and other uses exceed their drinking water consumption including but not limited to moviehouses, restaurants, gasoline stations and factories;
- 3. hotels, inns, pension houses;
- 4. hospitals;
- 5. apartment building with more than five (5) doors and condominiums or town houses with more than five (5) units;
- 6. educational institutions; and
- 7. buildings with more than two (2) storeys, the same way may construct their own water supply systems to meet their own water supply requirements, subject to the provisions of Section 4 of this ordinance, and in accordance with the provisions of the water Code of the Philippines of 1976 and the Provincial Water Utilities Act of 1973, as amended.

SECTION 3. - Water for drinking purposes drawn by any water system or well in the city shall pass a water potability test by the MNWD in coordination with the City Health Office;

SECTION 4. - The installation of water systems or construction of well within the city by any person, group, entity or establishment shall require a prior clearance from and shall be under the control and supervision of the MNWD, as provided in the Water Code of the Philippines of 1976 and the Provincial Water Utilities Act of 1973, as amended. To ensure safety and water quality, the same are obligated to terminate the operation of their water supply systems and thereafter interconnect with the water supply system of the MNWD once the district (MNWD) is capable of supplying their water requirements.

SECTION 5. - All establishments/buildings within the central business district are given a period of one (1) year within which to comply with this ordinance;

SECTION 6. - Any or all those enumerated in Section 2 hereof located outside the central business district are given a period of six (6) months within which to comply with this ordinance;

SECTION 7. - No plumbing plans for any building shall be approved and no building permit shall be granted by the City Building Official that does not conform to the provisions of this ordinance;

SECTION 8. - Any violation of this ordinance shall be penalized with imprisonment not exceeding one (1) year or fine not exceeding Five Thousand (P5, 000.00) Pesos or both imprisonment and fine at the4 discretion of the court;

SECTION 9. - This ordinance amends Ordinance No. 93-018;

SECTION 10. - This ordinance shall take effect upon the approval after the requisite posting and publication.
