ORDINANCE NO. 93-102

AN ORDINANCE REGULATING THE REGISTRATION AND USE OF AIR RIFLE IN THE CITY OF NAGA AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

ARTICLE I – TITLE AND SCOPE OF ORDINANCE

SECTION 1. - TITLE OF ORDINANCE. - This ordinance shall be known as “An Ordinance Regulating the Registration and Use of Air Rifle in the City of Naga”;

SECTION 2. - SCOPE OF ORDINANCE. - The provision of this code shall control, enforce, direct and supervise the registration and use of air rifle ion the City of Naga.

ARTICLE II – DEFINITION OF TERMS

SECTION 3. - WORDS AND PHRASES DEFINED. - As used in this ordinance:

- a. Air Rifle - Shall refer to a pistolized or long barelled gun powered by air or oxygen; used for sports and hunting purposes;
- b. Owner - Shall mean the actual legal owner is in custody of an air rifle;

ARTICLE III – PROHIBITIONS

SECTION 4. - RESTRICTIONS. - No air rifle shall be allowed to be used for any other purpose except for sports and hunting purposes only;

SECTION 5. - No air rifle shall be allowed in National Parks or forests reserves that may prejudice the preservation of birds and animals with rare species;

SECTION 6. - a. No minors shall be allowed to own or use an air rifle;

b. No person or dealer shall sell or dispose any air rifle to a minor.

SECTION 7. - REGISTRATION. - Every air rifle must be registered with the City Treasurer’s Office showing the following:

- a) Name of Owner
- b) Complete Address of the Owner
- c) Number of Units Applied

- d) Trade Mark/Made
- e) Serial Number
- f) Invoice Number & Date of Issuance
- g) Name of Dealer
- h) Business Address of the Dealer

For such registration, there shall be levied and collected a Mayor's Permit of TWO HUNDRED (P500.00) PESOS per unit, payable annually by the owner thereof and the payment to be made not later than the last day of January of every year. The registration fee shall not include the expenses for a Registration Sticker Number to be provided by the City Treasurer's Office. The Registration Sticker number shall be attached to the Air rifle.

A penalty equivalent to TWENTY FIVE (25%) PERCENT of the Mayor's Permit shall be charged per unit registered late.

ARTICLE IV. – PENALTY

SECTION 8. - Any owner or dealer of air rifle who violates any provision of this ordinance shall be fined the amount of Five Hundred (P500.00) Pesos or an imprisonment of not more than six (6) months or both such fine and imprisonment at the discretion of the court.

ARTICLE V – FINAL PROVISIONS

SECTION 9. - REPEALING CLAUSE. - All ordinances, rules, orders and regulations or parts thereof contrary to or inconsistent with any provisions of this ordinance are hereby amended, modified and/or repealed accordingly.

SECTION 10. - SEPARABILITY CLAUSE. - If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, the remainder of this ordinance and the application of such provision to other person or circumstances shall not be affected thereby;

SECTION 11. - EFFECTIVITY. - This ordinance shall be in full force and effect FIFTEEN (15) DAYS immediately after its publication in a local newspaper.
