ORDINANCE NO. 1994-008

AN ORDINANCE REQUIRING ALL CONTRACTORS AND PAQUIAO CONTRACTORS TO APPLY FOR ACCREDITATION WITH THE CITY ACCREDITATION COMMITTEE WHICH IS HEREBY CREATED FOR THE PURPOSE, DEFINING ITS COMPOSITION, FUNCTIONS AND RESPONSIBILITIES: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - TITLE. - This ordinance shall be known as “The Contractors and Paquiao Contractors Accreditation Ordinance of the City of Naga”;

SECTION 2. - SCOPE. - This ordinance shall cover all contractor and paquiao contractor operating and/or doing business in the City of Naga;

SECTION 3. - DEFINITION OF TERMS. - Terms and Phrases used in this ordinance:

- a. Paquiao contractor – for the purpose of this ordinance shall refer to person or persons engaged in construction business without license from the Philippine Contractors Accreditation Board;
- b. Contractor – for the purpose of this code shall refer to person or persons engaged in construction business and duly licensed by the Philippine Contractors Accreditation Board.

SECTION 4. - PROHIBITION. - No contractor a paquiao contractor shall be allowed to enter into a contract with the City Government of Naga in construction of various city infrastructure projects without accreditation by the City Accreditation Board;

SECTION 5. - The City Accreditation Committee is hereby created with the following composition:

SECTION 6. - The committee shall have the following functions and responsibilities:

- a. to accept applications for accreditation.
- b. to process and approve applications for accreditation.

c. to suspend or to cancel any accreditation already approved.

SECTION 7. - REQUIREMENTS FOR ACCREDITATION. -

A. For Paquiao Contrators:

1. Residence of the city as certified by the Barangay Captain.
2. Business or Mayor's permit.
3. Names and addresses of regular employees/laborers and their skills.
4. Work experience/contract completed.
5. Income Tax Return as certified by the BIR.
6. Letter of Intent.
7. Other requirements as the committee required.

B. For License Contractor:

Aside for the Pre-Qualification requirements submitted by the contractors for each project as publish by the City Government. The following papers or documents are required to be submitted for accreditation.

1. Contractors license as approved by the Philippine Contractors Accreditation Board;
2. Business/Mayor's Permit;
3. Organizational Structure;
4. Equipments (owned or rented);
5. Work experience/contract completed;
6. Income Tax Return as certified by the BIR;
7. Certified financial statement of Assets and Liabilities;
8. Letter of Intent;
9. Other requirements as the committee required.

SECTION 8. - Any contract entered into in violation of this ordinance shall be deemed void.

SECTION 9. - SEPARABILITY CLAUSE. - Any provision or portion of this ordinance found to be unconstitutional or invalid shall not impair the other provisions or parts thereof which shall continue to be in force and effect.

SECTION 10. - REPEALING CLAUSE. - Any or all ordinance, rules and regulations which are inconsistent or in conflict with the provision of this ordinance are hereby repealed and modified accordingly.

SECTION 11. - EFFECTIVITY. - This ordinance shall take effect upon its approval and after publication in a newspaper of local circulation.
