ORDINANCE NO. 94-063

AN ORDINANCE PROHIBITING VENDING INSIDE TRIMOBILE STATIONS AND ALL WAITING SHEDS AND PROVIDING PENALTIES THEREOF: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - DEFINITION OF TERMS. - As used in this ordinance:

- a. TRIMOBILE STATIONS Color-coded waiting sheds within the Central Business District for trimobile passengers.
- b. WAITING SHED a covered structure constructed for the use by the general public as a temporary cover against rain or sun while waiting for transportation and for similar purposes.
- c. VENDING the sale of any item from any makeshift stall, stand or other similar contraptions.

SECTION 2. - PROHIBITIONS. - Vending is hereby prohibited inside trimobile stations and waiting sheds and within a radius of 1 meter from the posts of the same structure.

- **SECTION 3.** EXCEPTIONS. The City Mayor may temporarily allow vending within and around specific trimobile stations and waiting sheds for a fixed number of days and within a fixed time period under any of the following conditions:
 - a. When the portion of the roads served by such station or shed is closed to traffic;
 - b. During the Peñafrancia religious, civic and military parade or during any other major festivity observed by the City.

Vendors shall voluntarily vacate the prohibited vending zone within and around trimobile stations and waiting sheds upon the lapse of the period specified by the City mayor, otherwise they shall be considered in violation of this ordinance.

- **SECTION 4.** PENALTIES. Violators of this ordinance shall be fined P200.00 and P500.00 for the first and second offenses, respectively, and P1, 000.00 for the third and succeeding offenses.
- **SECTION 5.** DISPOSITION OF CONFISCATED GOODS. Goods of items sold by vendors apprehended for violation of this ordinance shall be confiscated by the apprehending authority and brought to the nearest police station for safekeeping. They shall be released only upon the payment of the requisite fine except those owned by vendors apprehended for the third or more times in which case their goods shall be forfeited in favor of the government.

SECTION 6. - REPEALING CLAUSE. - All ordinances, resolution and issuances or parts thereof with this ordinance are hereby modified accordingly.

SECTION 7. - EFFECTIVITY. - This ordinance shall take effect upon its approval.
