ORDINANCE NO. 95-062

AN ORDINANCE REQUIRING ALL SALES PERSONS IN ALL STORES IN THE CITY OF NAGA TO WEAR OR DISPLAY IN HIS NAME TAG: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - USE OF NAME TAG. - All persons selling goods or merchandise in any/all kind or nature In the City of Naga, including but not limited to department stores, drugstores, hard wares, groceries, bakeries, etc., are required to visibly display on his/her person his name tag:

SECTION 2. - SIZE OF THE NAME TAG. - The size of the name tag shall not be no less than three inches by four inches which shall contain the name of the stores and the name of the sales person, provided, that the name of the sales person in the name tag shall be no less than three-fourths (3/4) of an inch and must be legible:

SECTION 3. - MANDATORY USE OF NAME TAG. - It shall be the duty of all sales persons to wear at all times while on duty his name tag, and it shall likewise be the responsibility of any store owner/manager to require and oversee at all times that all his sales persons in his store wear and display their name tags on their person visible to the customers;

SECTION 4. - STORE OWNERS TO PROVIDE NAME TAG. - It shall be the duty of store with more than five (5) sales persons to provide them with their nametags, and in stores with five (5) or less than five (5) sales persons shall provide themselves with their nametags;

SECTION 5. - PENALTY. - 1) The following shall be imposed upon sales persons for violation of this ordinance:

| a. For first offense | Fine of no less than P 200.00; |
| b. For second offense | Fine of no less than P 500.00 and/or imprisonment of ten (10) days; |
| c. For third offense | Fine of no less than P 1,000.00 and/or no less than eleven (11) days nor more than thirty (30) days. |

2. For failure of the store owner/manager to cause his/her sales persons to wear or put on his/her nametag shall suffer the following:

| a. For first offense | Fine of no less than P 500.00 |
| b. For second offense | Fine of no less than P 1,000.00 |
| c. For third offense | Fine of no less than P 1,500.00; |

SECTION 6. - REPEALING CLAUSE. - All ordinances, rules, orders and regulations or parts thereof contrary to or inconsistent with any of the provisions of this ordinance are hereby repealed.

SECTION 7. - EFFECTIVITY. - This ordinance shall take effect one month after approval and publication.
