ORDINANCE NO. 95-094

AN ORDINANCE AMENDING CERTAIN SECTIONS OF ORDINANCE NO. 94-008 OTHERWISE KNOWN AS "THE CONTRACTORS AND PAQUIAO CONTRACTORS ACCREDITATION ORDINANCE TO THE CITY OF NAGA", BY PROVIDING ADDITIONAL MEMBERSHIP TO THE COMMITTEE ON ACCREDITATION AND PROVIDING FURTHER REQUIREMENTS FOR PAQUIAO AND LICENSED CONTRACTORS AND FOR RE-ACCREDITATION:

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - SECTION 4 is hereby amended to read as follows:

SECTION 4. - PROHIBITION. - No contractor and Paquiao contractor shall be allowed to enter into any bidding and enter into any contract with the City Government of Naga in the construction of various city infrastructure projects without the proper accreditation by the City Accreditation Board as herein provided;

Any contract entered into by a contractor or paquiao contractor beyond his accreditation class or capacity shall be void.

SECTION 2. - SECTION 5 is hereby amended to include additional membership in the committee, now to read as follows:

SECTION 5. - The City Accreditation Committee is hereby created with the following composition:

Chairman:	Chairman, SP Committee on Infrastructure
Members:	The City Planning & Development Coordinator The City Legal Office Two (2) representatives coming from the Contractors association Chairman, SP Committee on Appropriations Chairman, SP Committee on Public Utilities

SECTION 3. - SECTION 7 shall be amended to provide for further requirements for contractors, and to read as follows:

SECTION 7. - REQUIREMENTS FOR ACCREDITATION. -

A – For Paquiao Contractors:

A-1 For projects not over P100,000.00

1. Resident and registered voter of the City of Naga as certified by his Barangay Captain of his residence and of the COMELEC.
2. Privilege tax receipt for the current year
3. Business or Mayor's Permit
4. Names and address of regular employees, laborers and their skills
5. Work experience/contract completed
6. Income Tax return as certified by the BIR
7. Letter of Intent
8. Other requirements as the committee may require

A-2 For projects costing above P100, 000.00 but not over P300,000.00

1. Resident and roistered voter of the City of Naga as certified by the Barangay Captain of his residence and the COMELEC.
2. Privilege tax receipt for the current year
3. Business or Mayor's Permit
4. Organizational structure showing data sheet of personnel
5. Statement of completed construction projects for the past year, government or private. The statement shall include the nature and value of the project, the name and address of the owner.
6. Income Tax Return for the preceding year
7. Letter of Intent
8. Detailed statement showing a list of all on going construction projects, governments or private, as well as awarded and/or approved contracts not yet started. This statement shall include the value of the project percentage of time elapsed, percentage of physical accomplishment and scheduled date of completions.
9. List of owned equipment
10. Community, tax certificate showing amount paid
11. Other requirements as the committee may require

B. For Contractors for projects costing P 300,000.00 and above

1. Contractors license as approved by the Philippine Contractors Accreditation Board.
2. Privilege tax receipt for the current year
3. Business or Mayor's Permit
4. An organizational chart showing complete qualification and experience data sheet of personnel employed
5. List of owned equipment
6. Statement of completed construction projects for the past two (2) years, government or private. The statement should include the nature and value of the project, the name and address of the owner; the financial institutions from the guarantee, credit line, loans and other financial accommodations were secured for such projects.
7. Detailed financial statements (balance sheets and profit and loss statements) for the current year.
8. Letter of Intent
9. List of equipment owned
10. Articles of partnership or incorporation when applicable
11. Income Tax return as certified by the BIR
12. Other requirements as the committee may require.

SECTION 4. - The ordinance is also amended by providing for an additional subsection to read as follows:

SECTION 7-A. - RE-ACCREDITATION. - All Paquiao contractors and already accredited shall again apply for re-accreditation in accordance with the foregoing amended provisions within a period of one (1) month from the approval of this ordinance or until January 31, 1996 and failure to so renew or re-accredit shall be deemed cancelled and void.

Re-accreditation will be done during the month of January of the following year and thereafter

Any contractor already accredited in one category can no longer be accredited in another.

SECTION 5. - This ordinance shall take effect upon its approval.
