ORDINANCE NO. 96-001

AN ORDINANCE REQUIRING ALL OPERATORS OF TRIMOBILE FOR HIRE IN THE CITY OF NAGA TO HAVE THEIR UNITS FULLY PAINTED WITH THEIR ASSIGNED COLOR-CODE EFFECTIVE JANUARY 1, 1996 OR UPON RENEWAL OF THEIR MAYOR'S PERMIT AND/OR FRANCHISE FOR THE SAME ABOVE-MENTIONED CALENDAR YEAR: -

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - All operators of trimobile for hire in the City of Naga are hereby required to have their units fully painted with their assigned color-code effective January 1, 1996 or upon renewal of their Mayor's Permit and/or franchise according to the following schedule:

BLUE	0001	0609	609 units
RED	0610	0758	149 units
GREEN	0759	1046	288 units
YELLOW	1047	1500	454 units

SECTION 2. - BODY PAINTING. - The body painting of all trimobile units for Hire shall be done free by the City Government of Naga. This free painting shall be given only once and not beyond March 15, 1996.

Succeeding repainting and painting of new units shall be the responsibility of the operator concerned.

The phrases "USWAG NAGA" and "PROUD TO BE A NAGUENO" may be painted also on the appropriate spaces of the trimobile sidecar's front and outside back portions.

The cost of painting of the trimobile registration number with the Alpha Numeric Code of the Land Transportation Office (LTO) and the words "USWAG NAGA", "PROUD TO BE A NAGUENO", Naga City and year, name and address of operator or franchise holder and authorized fare shall as usual be borne by the operator.

The official color of "USWAG NAGA" and "PROUD TO BE A NAGUEÑO" shall be adopted with white background.

SECTION 3. - This ordinance amends pertinent provisions of Section 117 of Ordinance No. 93-049, otherwise known as the Transport & Traffic Code of Naga City.

SECTION 4. - PENALTY. - Non-compliance of any provision of this ordinance shall mean non-renewal of Mayor's Permit and/or issuance of Motorized Trimobile Operator's Franchise (MTOF).

SECTION 5. - This ordinance shall take effect upon its approval.
