**ORDINANCE NO. 96-006**

**AN ORDINANCE REGULATING THE USE OF ROLLER BLADES AND ROLLER BOARDS ON PUBLIC ROADS AND STREETS IN THE CITY OF NAGA AND PROVIDING PENALTIES FOR VIOLATION THEREOF: -**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1. - DEFINITION OF TERMS. -** as used in this Ordinance:

- a) Roller Skates - a metallic or plastic runner made of combination of metal frames, PVC (PolyVynyChloride) or PU (PolyUrethane) materials with a frame shape to fit the sole of a shoe used for skating sports or otherwise.
- b) Roller Blades - a pair of plastic runner up of at least four (4) PVC roller/wheels aligned one after the other mounted on a plastic high cut shoes to fit a pair of the user or skater, commonly worn in skating rings, etc.
- c) Roller Boards - an oblong piece often wood or plastic materials with approximate thickness not exceeding 2 ½ inches and a length of more or less 6 inches and width of more or less 6 inches mourned on two pairs of roller wheels, made of metal or PVC materials used for skating sports or otherwise.
- d) Road - an open way or public passage for vehicles, persons and animals; a track for travel or for conveying goods, etc. between one place to another. A road is generally applied to a highway outside of an urban district, as distinct from a street which is a highway in an urban district.
- e) Street - commonly referred to as a thoroughfare, especially in a city, town or village distinguished from an alley or lane or from a national road or highway. It usually includes the sidewalks or footpaths on either side.
- f) Skater - any person that perform an act of skating using a roller skates, roller blades and roller boards for fun, sports or otherwise.

**SECTION 2. -** Any person shall not be allowed to perform an act of skating using roller skates, roller blades and roller boards on all public roads and streets located within the City of Naga.

It shall be unlawful for any person or persons to use any public road and street while performing the act of skating for fun, sports or otherwise.

**SECTION 3. -** Any person who violates Section 2 of this Ordinance shall be penalized by a fine of not less than Five Hundred (p500.00) Pesos but not more than One Thousand (P1,

000.00) Pesos or by imprisonment of not less than fifteen (15) days but not exceeding thirty (30) days or both at the discretion of the court, plus the confiscation of the roller skates/blade or board used by a violator.

**SECTION 4.** - The violator's confiscated roller skate/blade or board shall be turned over to the City Property Custodian for safekeeping.

**SECTION 5.** - All ordinances, resolutions, rules and regulations, or provisions thereof, which are in conflict with or inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

**SECTION 6.** - This ordinance shall take effect immediately upon its approval.
