ORDINANCE NO. 96-033

AN ORDINANCE AMENDING ORDINANCE NO. 93-049, OTHERWISE KNOWN AS "THE TRANSPORT AND TRAFFIC CODE OF NAGA CITY" SPECIFICALLY SECTIONS 134 AND 136, ARTICLE XXVIII ON REGULATIONS OF PADYAKS:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - Ordinance No. 93-049, otherwise known as "The Transport & Traffic Code of Naga City", specifically Sections 134 and 136 of Article XXVIII on the "Regulations of Padyaks" are hereby amended by adding certain provisions thereto, now to read as follows:

"SECTION 134. - REGISTRATION. -

- 1. Every "padyak" for hire must be registered with the City Treasurer's Office showing the following:
 - a. Name of Owner/Operator
 - b. Complete address of owner/operator
 - c. Number of units applied
 - d. Name of authorized driver & address
 - e. Verified xerox copy of Original Third Party Liability Insurance coverage of P10,000.00 for driver and two (2) passengers.

"SECTION 136. - (a) For padyaks, there will be two (2) light bulbs generated by any device, one bulb placed on the front side of the bicycle and the other on the right side of the sidecar, and a reflectorized device installed at the back.

- b. All padyak units that shall operate in the City of Naga shall be uniformly designed with a covered sidecar and driver's seat made of canvass following the design and specifications as hereto attached and marked as Annex "A".
- c. The padyak unit itself shall be painted according to the padyak plate color assigned to each area of operation as indicated in Section 134, Sub-Section 6 of same ordinance.

Padyak color plate of units in new areas of operation shall be determined by the City Treasurer.

- d. All padyak owners/operators are hereby given until January 1, 1997 within which to comply with the provisions of this ordinance on insurance and canvass covering and painting requirements or registration shall not be issued.
- e. All padyak owners/operators that have already complied with the nearest specification of canvass cover shall be retained.

SECTION 136-A. - Motorized padyak is strictly prohibited in the City of Naga. Motorized padyak shall refer to padyak mounted with and operated by a motoring machine or generator or other similar device."

SECTION 2. - PENALTIES. - (a) Any padyak owner or operator found guilty of violating Section 136, Sub-Sections (a), (b), (c) and (d) hereof shall be penalized with a fine of FIVE HUNDRED (P500.00) PESOS or an imprisonment of ONE (1) MONTH, or both such fine and imprisonment at the discretion of the court.

b. For violation of Section 136-A, owner or operator and the driver of the prohibited motorized padyak shall be penalized with a fine of ONE THOUSAND (P1,000.00) PESOS or an imprisonment of ONE (1) MONTH, or both such fine and imprisonment at the discretion of the court.

Upon apprehension in either case, subject padyak shall be impounded at the PNP Station and shall be subject to the pertinent provisions of Sections 101, 102 and 103 of Article XX of Ordinance No. 93-049.

Violator in all cases may avail of the provisions of Ordinance No. 95-093, otherwise known as "The Administrative Fine and Penalties Ordinance", subject to the following schedules:

First Offense 25% of the fine provided in the ordinance. Second Offense 50% of the fine provided in the ordinance. Third Offense 75% of the fine provided in the ordinance.

SECTION 3. - EFFECTIVITY. - This ordinance shall take effect upon its approval and after publication in a newspaper of local circulation.
