### ORDINANCE NO. 97-103

**AN ORDINANCE FURTHER AMENDING ORDINANCE NO. 97-057, AS AMENDED BY ORDINANCE NO. 97-083, ENTITLED: "AN ORDINANCE REQUIRING THE PRESENTATION OF SSS CLEARANCE PRIOR TO ISSUANCE OF MAYOR'S PERMIT/BUSINESS LICENSE TO EMPLOYERS/BUSINESS ESTABLISHMENTS AND TO FURTHER REQUIRING THESE EMPLOYERS/BUSINESS ESTABLISHMENTS TO PROMINENTLY DISPLAY THEIR SSS CERTIFICATES OF REGISTRATION", BY ADDING A PROVISOIR IN SECTION 4 THEREOF:-**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** - Ordinance No. 97-057, entitled: "An Ordinance Requiring Presentation of SSS Clearance Prior to Issuance of Mayor's Permit/Business License to Employers/Business Establishments and the Prominent Display of the SSS Certificate of Registration" as amended by Ordinance No. 97-083 is hereby further amended, now to read as follows:

#### **ARTICLE I**

"SECTION 1. - TITLE. - This ordinance shall be known as the "Ordinance Requiring Presentation of SSS Clearance Prior to Issuance of Mayor's Permit to Employers/Business Establishments and the Prominent Display of the SSS Certificate of Registration in the Business Establishment."

"SECTION 2. - COVERAGE. - This ordinance shall be enforced upon all employers doing business within the territorial jurisdiction of the City of Naga.

#### **ARTICLE II**

"SECTION 3. - SSS CLEARANCE REQUIREMENT. - Before any mayor's permit is issued to employers/business establishments in the City of Naga, they shall be required to present a clearance from the SSS.

"SECTION 4. - ISSUANCE OF MAYOR'S PERMIT. - No mayor's permit shall be issued or granted to any employer/business establishment without complying with the provisions of the preceding section. Provided that should the SSS failed without cause to issue its clearance to any applicant within five (5) days from filing thereof, in accordance with the Memorandum of Agreement between the SSS and DILG, the City of Naga may issue the Mayor's Permit in the absence of SSS clearance upon prior consultation with the latter.

"SECTION 5. - DISPLAY OF SSS CERTIFICATE OF REGISTRATION. - The SSS Certificate of Registration must be prominently displayed in the business establishment together with their business permit/license.

### **ARTICLE III**

“SECTION 6. - PENAL PROVISION. - Whoever fails or refuses to comply with the provisions of Section 5 hereof shall be punished by a fine of not less than Three Hundred Pesos (P300.00) or imprisonment for not more than one (1) month or both at the discretion of the court.

**SECTION 2. - EFFECTIVITY.** - This ordinance shall take effect after fifteen (15) days from its publication in a local newspaper of general circulation.”
