**ORDINANCE NO. 98-108**

**AN ORDINANCE CREATING THE NAGA CITY FAMILY AND CHILDREN COUNCIL, DEFINING ITS COMPOSITION, FUNCTIONS AND RESPONSIBILITIES, PROVIDING NECESSARY FUNDS FOR THIS PURPOSE; AND FURTHER DECLARING MONTH OF JANUARY, 1999 AND EVERY YEAR THEREAFTER AS "FAMILY & CHILDREN'S MONTH IN THE CITY OF NAGA:-**

Be it ordained by the Sangguniang Panlungsod of the City of the City of Naga, that:

**SECTION 1. - TITLE. -** This ordinance shall be known as the "Naga City Family and Children Council and Family Month;

**SECTION 2. -** The Naga City Family and Children Council is hereby created and shall be composed of the following:

**SECTION 3. - Functions and Responsibilities. -** The Naga City Family and Children Council shall perform the following functions and responsibilities:

- a. Formulate programs and projects related to fortify solidarity in the family and actively work for its development and sustainability; and to ensure awareness of the importance of family as the foundation of the nation;

- b. To coordinate with the regional offices in its activities invoking Presidential Proclamations declaring the National Family Week and the Children's Month;
- c. To formulate programs and related activities during the Celebration of the "Family and Children Month" in the City of Naga;
- d. To give fresh to the legal mandates as embodied in the Family Code, RA 7610, RA 7658 for the protection of Filipino family and children; and
- e. To perform such other functions which concern family and children.

**SECTION 4.** - A Secretariat and Technical Working Group are hereby created and composed of the following: the CSWD Representative, DECS Representative, Metro Peso Representative, City Mayor's Office Representative, CPDO Representative and the Liga ng mga Barangay Representative, UPAO Representative, SP Representative, and the NCPC Representative.

**SECTION 5.** - It is hereby declared that the month of January shall be the Family and Children's Month in the City of Naga.

**SECTION 6.** - FUNDING. - The amount of One Million Pesos (P1,000.00) is hereby appropriated for this purpose, chargeable against the 1999 Annual Budget.

**SECTION 7.** - EFFECTIVITY. - This ordinance shall take effect upon its approval.
