ORDINANCE NO. 98-109

AN ORDINANCE FURTHER AMENDING ORDINANCE NO. 92-048, OTHERWISE KNOWN AS THE "REVISED SANITARY CODE OF NAGA CITY", AS AMENDED BY ORDINANCE NOS.93-002, 93-050, 93-029, AND 98-052:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - SECTION 70 of Ordinance No. 92-048 is hereby amended, now to read as follows:

X X X X X X X X X X

Pink Card shall be issued to all registered GRO's for which a fee of fifty (P50.00) pesos shall be charged and which shall be renewed annually each pink card bears the GRO's identification as well as control number and shall contain records of smear examination which shall be done once a week. Smear fees shall be charged at twenty five (P25.00) pesos per smear.

SECTION 2. - Section 71 of Ordinance No. 92-048 is hereby amended, now to read as follows:

"SECTION 71. - All hostesses/hosts/hospitality girls/boys now known as Guest Relations officers/Space Councilors working in the City of Naga are hereby required to secure HIV-AIDS, RPR, HEPA-B Clearance every January and July from the Naga City Hospital before the issuance of a Working Card/Pink Cards from the Local Health Office;"

It shall be unlawful for any person, owner or operator of bars, discos, massage parlors, night clubs and other similar business establishments in the City of Naga to hire or employ any GRO's without the required HIV-AIDS, RPR, HEPA-B Clearances and the working card/Pink Card as mentioned in the preceding paragraph."

All hostesses/hosts/hospitality girls/boys now known as Guest Relations Officers/Space Councilors and owners of establishments specified in this section are hereby governed by the following rules and regulations:

- a. Uniform The management shall design or prescribe the appropriate uniform for their GRO's/Entertainer in their establishment. Failure of the management to implement this ordinance will be penalized.
- b. With the high rise of STD incidence and discovery of resistant STD pathogenic microorganism, a weekly smear of the Urethro Cervical secretions shall be conducted.

- c. Identified positive (+) cases shall not be allowed to work unless they are through with their medications and repeat smear examination result shall be found negative(-).
- d. No pregnant GRO's shall be allowed to work in order to safeguard their health and the health of the unborn child, in relation with the safe motherhood program of the DOH.
- e. Pink Card must be in their possession when rendering service with no erasure or alteration on the said card unless provided by authorized RHC staff and countersigned. Violation of above said provision shall be subject to a penalty of five hundred pesos (P500.00) and an imprisonment of one (1) month but not exceeding six (6) months or upon the discretion of the court.
- f. The management should notify the City Health Officer of their respective GRO's going on leave of absence or in inactive status and shall undergo smear examination before reinstating. Failure to do so, the management and GRO's shall be penalized under Chapter IX" (Section 71 of this ordinance);

SECTION 3. - SECTION 111, Chapter XIV of Ordinance No. 92-048 is hereby amended, now to read as follows:

"SECTION 111. - It is prohibited for any person/s to construct or put up a poultry house or domestic pigpen (Tangcal) or to rear or care for any pig, or livestock's in urban barangays in the City of Naga.

It is permitted for any person/s to construct or care for any pig, or livestock's in rural barangays but with a distance of at least twenty (20) meters from any neighboring or residential dwelling, and shall be provided with septic tank."

SECTION 4. - SECTION 119, Chapter XVI of Ordinance No. 92-048 is hereby amended, now to read as follows:

a. For violation of Section III person concerned shall be dealt with the following:

- b. For violation of Sections 12, 13, 15, 16, 20, 36, 37, 38, 53, 81, 82, 83, 100, 101, 106 and 107, five hundred (P500.00) pesos or imprisonment of not exceeding one month of both fine and imprisonment upon the discretion of the court.
- c. For violation of sections 5,6,7,8,9,10,11,30,39,40,41,42,56,57,58,59,60,64,66,67,69,79,85,87,88,89,9 0,97,99,102,103 and 109, shall be penalized with a fine of not less than five hundred (P500.00) pesos and an imprisonment of not less than one (1) month but not more than six (6) months or both upon the discretion of the court.

- d. For violation of section 89 and 104 the guilty person or party shall be penalized with a fine of not less than five hundred (P500.00) pesos or imprisonment of six (6) months but not more than two (2) years or both fine and imprisonment upon the discretion of the court.
- e. For violation of Sections 70 &71:

Any violation of any other provision of this ordinance not covered by the preceding section shall be penalized as follows:

SECTION 5. - EFFECTIVITY. - This ordinance shall take effect upon its approval and after publication in a newspaper of local circulation.
