Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - Ordinance No. 543, s. 1976 as amended by Ordinance No. 89-062, s. 1989 as amended by Ordinance No. 93-053 s. 1993 is hereby further amended by levying new rates of fees for the use of equipment and facilities of the Naga City Abattoir in the slaughter of the following animals thereat, to wit:
