## **ORDINANCE NO. 99-027**

## AN ORDINANCE PRESCRIBING FEES AND CHARGES FOR THE USE OF THE PLAZA QUEZON AND THE NAGA CITY GYMNASIUM INCLUDING THEIR FACILITIES IN THE, CITY OF NAGA BY PRIVATE INDIVIDUALS, COMPANIES OR GROUPS:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** - TITLE. - This ordinance shall be known as "The Plaza Quezon and Naga City Gymnasium Utilization Ordinance".

**SECTION 2.** - It is hereby prescribed the following fees and charges for the use of the Plaza Quezon and the Naga City Gymnasium including their respective facilities in the City of Naga by private individuals, companies or groups, as follows:

Government sponsored activities including those of the Barangay shall be exempted from this ordinance provided a duly approved Mayor's Permit is secured.

In case of damages during the use of these facilities and equipment of the Plaza Quezon and the Naga City Gymnasium, the individual, company or group hosting the event shall be held liable.

**SECTION 3.** - PAYMENT OF FEES AND CHARGES. - Collection of fees and charges shall be paid directly to the City Treasurer's Office before the Mayor's Permit may be issued.

**SECTION 4.** - TRUST FUND. - All fees and charges derived from the Plaza Quezon and the Naga City Gymnasium shall be deposited by the City Treasurer in a Trust Fund which is hereby created to cover the maintenance and operating expenses of both.

**SECTION 5.** - EFFECTIVITY.\_ - This ordinance shall take effect upon its approval and publication in a local newspaper of general circulation.
