



**ORDINANCE NO. 99-078**

**AN ORDINANCE AMENDING ORDINANCE NO. 95-031 CREATING THE NAGA CITY COUNCIL FOR YOUTH AFFAIRS OFFICE DEFINING THE COMPOSITIONS, DUTIES, FUNCTIONS AND RESPONSIBILITIES, SPECIFICALLY SECTION 2,3,5,6,7 AND 10 THEREOF:**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** - SECTION 2 letter a & d of Ordinance No. 95-031 is hereby amended now to read as follows:

- a. Youth – for purposes of this ordinance, shall refer to youth both male and female between the age of 15 years old to 30 years old.”

- d. Working Youth – youth who are employed, self-employed or under-employed.”

**SECTION 2.** - SECTION 3 letter b & c is hereby amended, now to read as follows:

- b. Representatives from:

- 1. Out-of-School Youth
- 2. In-school Youth
- 3. Working Youth
- 4. Special Youth

- c. Two (2) advisers to be selected by the Council subject to the confirmation of the City mayor.”

**SECTION 3.** - SECTION 4 of Ordinance No. 95-031 is hereby amended, now to read as follows:

“SECTION 4. - “TERMS OF OFFICE. - “The Chairman and all the members of the Council shall hold office during their incumbency in their respective organizations and in no case shall not exceed five (5) years.”

**SECTION 4.** - SECTION 5 is hereby amended by deleting the phrase “duly organized and recognized” and replacing it with the word “accredited”, now to read as follows:

“ SECTION 5. - GOVERNING BODY. - The Naga City Council for Youth Affairs is the highest policymaking and governing body of all youth organizations existing within Naga City and accredited by the council. All members of the council shall be elected by the different youth sector and accredited organization.”

**SECTION 5.** - SECTION 6 is hereby amended, now to read as follows:

- 13. Conduct an annual Inter-organization.
- 14. Conduct an annual youth summit.
- 15. Establish a physical fitness center at the Naga City Youth Center.”

**SECTION 6.** - SECTION 7 is hereby amending by deleting the word “registration” now to read as follows:

“SECTION 7. - “ACCREDITATION /REGISTRATION. - All youth organizations existing within Naga City shall submit accreditation requirements with the office of the Naga City youth affairs council. The following requirements shall be submitted”.

**SECTION 7.** - SECTION 10 is hereby amended by deleting the phrase “(a) on the first day of session following the confirmation by the city mayor of the appointment of all its members and within sixty (60) days thereafter shall adopt its own rules and procedures to be observed.” Now to read as follows:

“SECTION 10. - INTERNAL RULES AND PROCEDURES. - The internal rules and procedures shall provide for the following:
