



ORDINANCE NO. 99-089

AN ORDINANCE FURTHER AMENDING ORDINANCE NO. 93-028 AS AMENDED BY ORDINANCE NO. 93-030 AND ORDINANCE NO. 98-070 ENTITLED: “AN ORDINANCE ESTABLISHING AND AUTHORIZING THE GOVERNMENT EMPLOYEES MEDICAL SERVICES FOR ALL NAGA CITY GOVERNMENT EMPLOYEES BY EXPANDING ITS COVERAGE”:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - SECTION 4 of Ordinance No. 93-028 as amended by Ordinance No. 93-030, and further amended by Ordinance No. 98-070, entitled: “An ordinance establishing and authorizing the Government Employees Medical Services (GEMS) for all Naga City Government Employees, is hereby amended to expand its coverage as follows:

“SECTION 4 - the following are qualified to avail free services, discounts on laboratory charges and discounts on medicines from Naga City Hospital:

1. NAGA CITY GOVERNMENT EMPLOYEES - all City Officials and Employees (casual, permanent and contractuels) including offices rendering front-line services in Naga City are entitled to 100% discount (FREE) on medical services including hospitalizations, laboratory fees and medicines. These offices/agencies are as follows:
 - a. Naga City Government Schools in all levels
 - b. Naga City Philippine National Police
 - c. Naga City Jail Management Bureau
 - d. Naga City Fire Protection Bureau
 - e. Barangay Health Workers (BHW)
 - f. Barangay Day Care Workers (BDCW)
 - g. Barangay Nutrition Scholars (BNS)
 - h. Supplemental Feeding Volunteers (SFV)
 - i. Barangay Service Point Officers (BSPO)
 - j. Barangay Officials and Tanods
 - k. Sanggunian Kabataan Kagawad

Note: Identification card shall be presented by the concerned upon consultation in the Hospital. Non-presentation of the ID is sufficient reason for denial of Hospital benefits. Dependents are entitled to 25% discount.

4. SENIOR CITIZEN LEAGUE MEMBERS. - Free consultation and 25% discount on medicines and laboratory services.

Note: Identification card shall always be presented by the concerned, upon consultation in the Hospital.

SECTION 2. - This Ordinance shall take effect upon its approval.
