**ORDINANCE NO. 2000-052**

**AN ORDINANCE AMENDING SECTION 57, ARTICLE XVI OF ORDINANCE NO. 93-049, AS AMENDED, OTHERWISE KNOWN AS “THE TRANSPORT AND TRAFFIC CODE OF NAGA CITY “BY ADDING ANOTHER PARAGRAPH THERETO ON TRAFFIC RE-ROUTING SCHEME OF ALL VEHICLES LEADING TO THE CENTRAL BUSINESS DISTRICT II:-**

Be it ordained by the Sangguniang Panlungsod of the City of Naga that;

**SECTION 1.** - SECTION 57, Article XVI of ordinance No. 93-049, as amended, otherwise known as the “Transport and Traffic Code of Naga City”, is hereby further amended by adding another paragraph thereto on traffic re-routing scheme of all vehicles leading to the Central Business District II, now to read as follows;

“SECTION 57. - INTRA & INTER CITY TRAFFIC ROUTES. -

a. Public Utility Jeepneys (PUJ), Trimobiles, Trucks & Private Vehicles

b. The new Traffic Re-routing Scheme of all vehicles leading to the Central Business District II (CBD) coming from outside or within the territorial jurisdiction of the City Naga shall be strictly followed itemized hereunder:

1. Magsaysay Loop Service “A” Passenger Jeepneys traveling from Magsaysay Avenue going to Roxas Avenue shall enter/or turn right to the service entrance road in front of the ALDP and loading and /or unloading passengers at the New Central Bus Terminal and shall exit at the said service road then turn right along Roxas Avenue, turn right to Tabuco in going to CBD-I then to Peñafrancia and Magsaysay Avenue.
2. Magsaysay Loop Service “B” Passenger Jeepneys Traveling from Magsaysay Avenue shall turn left to Peñafrancia in going to CBD-I, then going to Tabuco, left to Roxas Avenue, left to the service road entrance in front oOf ALDP and loading and/or unloading passengers at the New Central Bus Terminal and shall exit at said road entrance, turn left to Roxas Avenue then to Magsaysay.
3. Multi-cab Loop Service “G” Passenger Jeepneys traveling from Dayandang shall turn right to Del Pilar Street, left turn to Panganiban,

right turn to Apo Drive, left to Mayon left turn to Panganiban, right turn to Naga City Subdivision (Sampaguita Street) right turn to Rizal Street, left to Carnation Street, right to service road leading to Naga Central Bus Terminal, then load and unload passengers, then left turn to Panganiban, left turn to Lerma, then turn to Gen. Luna back alley, right to Caceres Street proceed to Dinaga, right turn to Panganiban, then left Blumentritt then to Dayangdang.

4. Multi-Cab Loop Service "H" Passenger Jeepneys traveling from Dayangdang to Blumentritt shall turn right to Panganiban left turn to Elias Angeles, right to Caceres Street, left to Gen. Luna Street proceed to Tabuco Bridge, left to PNR Road, left Balintawak, right to Lerma, right to Panganiban, right turn to service road leading to New Central Bus terminal, then load and unload passengers, exit at Naga City Subdivision Service Road, then left turn Carnation Street, right to Rizal Street, left to Sampaguita, left to Panganiban, right to Mayon, right to Apo Drive, to Maria Cristina Street then turn right to Del Pilar then turn left to Dayangdang;
5. Multi-Cab Loop service "I" Passenger Jeepneys traveling along Roxas shall turn left to service road entrance in front of ALDP, load/unload passengers in front of the New Central Bus Terminal, left turn to Panganiban Dive right to Peñafrancia, left to Arana, left to J. Hernandez, right to Zamora, left to Tabuco-Sabang Bridge towards Ave., then to CBD II;
6. Naga-Del Rosario Via Diversion Passenger Jeepneys traveling from Del Rosario shall turn left to Roxas Avenue then right to service road entrance in front of ALDP, loading and/or unloading passengers at the New Central Bus Terminal and shall exit at the service road entrance then right turn to Roxas Avenue to Tabuco then to Gen. Luna Street, left to P. Burgoz Street, left to J. Hernandez, left to Zamora then right turn to Tabuco, left to Roxas Avenue then pass again at the said terminal then out;
7. Naga-Del Rosario Via Diversion and via LCC Passenger jeepneys shall take the same route of the above-cited (#6) jeepneys except upon reaching J. Hernandez Street shall turn right to Abella then left to Felix Plazo Street then load and unload passengers at LCC then exit at Sabang-Tabuco Bridge, pass again at said terminal then out;
8. Naga-Concepcion via Panganiban passengers Jeepneys traveling from Concepcion Grande Jeepneys going via CBD shall turn to service road entrance besides the Old Mother Seton Hospital load and unload passengers in front of New Central Bus Terminal, CBD II then exit and left turn to Panganiban right to Peñafrancia Avenue, left to Arana, left J. Hernandez, left to Zamora, left to Gen. Luna back alley, right to Padian then Dinaga, right to Panganiban Drive, right to service road entrance going to Terminal then exit at service road entrance going to Terminal then exit at service road entrance besides the Old Mother Seton Hospital then out. Likewise jeepneys going via Panganiban and CBD II for purposes of avoiding confusion on the part of the riding public shall be required to post a "route" sign board" indicating a clear destination. (PLS. SEE MAP)

9. Naga-Del Rosario via Panganiban and via LCC Passenger Jeepneys. They must follow the same route of the above item No. 8, except upon reaching corner J. Hernandez, shall turn right to Abella Street, left to Felix Plazo then load/unload passengers in front of LCC Complex, then left turn to Bagong Sirang, left to San Jose Street, passing Garcia Street, then right to Gomez Street, left to Zamora, left to General Luna back alley, right to Padian then Dinaga, right to Panganiban Drive, right to service road entrance going to Terminal then exit at service road entrance besides the Old Mother Seton Hospital then out. Likewise jeepneys going via Panganiban and CBD II for purposes of avoiding confusion on the part of the riding public shall be required to post a "route sign board" indicating a clear destination. (Pls. see map)
10. Passenger buses and mini-buses coming from Partido Area and Legazpi City traveling along Concepcion Pequeña shall turn left Roxas Avenue then turn right to service road entrance in front of ALDP then proceed inside the New Bus Terminal, load and unload passengers then exit Roxas Avenue.
11. ALL Buses and Mini Buses coming from Metro Manila and Mabolo traveling along Roxas Avenue shall turn left to service road entrance in front of ALDP PROCEED INSIDE THE New Central Bus Terminal, load and unload passengers then exit Roxas Avenue.
12. All Passenger Trimobile coming from Panganiban Drive and Bgy. Triangulo shall load/unload passengers in front of the New Central Bus Terminal, then exit only either Triangulo or Panganiban drive. They will not be allowed to ply within the stretch of Roxas Avenue after the road entrance going to Bgy. Triangulo direction East.
13. Private Vehicles ferrying their families/relatives coming and going to Central Bus Terminal, CBD II shall enter and exit any road accessibility along Panganiban Drive or Roxas Avenue. They are strictly not allowed to enter the premises except the area designated solely for them.
14. Eastbound Passenger Jeepneys coming from Partido and Rinconada traveling along Concepcion Pequeña shall turn left to Roxas Avenue, right turn to Carnation Street, Naga City Subdivision, then left to service road leading to CBD II then proceed to integrated Jeepney Terminal CBD II, then exit at Panganiban Drive.
15. South Bound Passenger Jeepneys coming from Ragay, Sipocot, Libmanan, Pasacao, Pamplona, San Fernando, Minalabac, Milaor and Gainza traveling along Roxas Avenue shall turn left to service road entrance in front of ALDP then proceed to Integrated Jeepney Terminal, load and unload passengers then exit again at the said road entrance then out.
16. Trucks shall only be allowed to enter the vicinity of the new Central Bus Terminal, CBD II at any access road except Naga City Subdivision Roads."

**SECTION 2. - SEPARABILITY CLAUSE.** - All Ordinances, resolutions, orders, rules and regulations or part thereof inconsistent with any provision of this Ordinance, are hereby repealed, amended and/or modified accordingly;

**SECTION 3. - EFFECTIVITY.** - This Ordinance shall take effect upon its approval and after publication in a newspaper of local circulation.
