**ORDINANCE NO. 2000-074**

**AN ORDINANCE WITHDRAWING FROM PUBLIC SERVITUDE THE EVANGELISTA AND KINASTILLOHAN STREETS IN THE CITY OF NAGA AND DESIGNATING THE SAME AS SITE OF THE "KAMUNDAGAN TRADE FAIR 2000" FROM DECEMBER 1-31, 2000 ONLY, AND PRESCRIBING RATE OF RENTAL THEREFORE: -**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** - The following streets in the City of Naga are hereby withdrawn from public servitude and designated as site of the "Kamundagan Trade Fair 2000" from the period December 1-31, 2000 only, to wit:

- a. Evangelista Street - right side only from E. Angeles Street to General Luna Street. This area shall be occupied by the Manila Vendors;
- b. Kinastillohan Street - both sides from E. Angeles Street to General Luna Street. Right side of this area shall be occupied by the local vendors and the left side shall be occupied by the Manila Vendors;

**SECTION 2.** - The construction of stalls shall be undertaken by and at the cost of the occupants.

PROVIDED, that no stall shall be constructed within six (6) meters from any corner of street herein identified.

**SECTION 3.** - MEASUREMENT OF STALLS. - The measurement of stalls shall be at least 2 x 2 or a total area of 4 square meters per stall;

**SECTION 4.** - The Market Awards Committee with the assistance of the Federation of Market Stallholders shall execute the fair and just distribution and awarding of stalls for the local vendors;

**SECTION 5.** - RATE OF RENTAL. - Within the period defined in Section 1 hereof, the rate of rental shall be Nine Hundred (P900.00) Pesos per stall to be paid directly to the Office of the City Treasurer;

**SECTION 6.** - The stall occupants are hereby required to maintain cleanliness, peace, and order in their Premises during the entire period herein specified.

**SECTION 7.** - EFFECTIVITY. - This ordinance shall take effect upon its approval, and during the entire period of the "Kamundagan Trade Fair 2000" only.
