## **ORDINANCE NO. 2001-010**

## AN ORDINANCE AMENDING SECTIONS 1,2, 4 AND 5 OF ORDINANCE NO. 95-049, ENTITLED: "AN ORDINANCE CREATING THE NAGA CITY COOPERATIVE COUNCIL, DEFINING ITS COMPOSITION, FUNCTIONS AND RESPONSIBILITIES" AND ADDING NEW SECTIONS THERETO:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** - Sections 1, 2, 4 and 5 of Ordinance No. 95-049 are hereby amended now to read, as follows:

"SECTION 1. - The Naga City Cooperative Development Council (NCCDC) created under Ordinance No. 95-049 shall now be composed as follows:

"SECTION 2. - Selection and Appointment of the Private Sector Representatives to the NCCDC. The Federation of Naga City Working Club, the Naga City Federation of Cooperatives (NCFC), shall within 30 days from the effectivity of this ordinance, choose among their members and through a process independently determined by them, five (5) and three (3) nominees respectively, for appointment to the NCCDC by the City Mayor. Within the same period, the NCFC and the NCPC shall jointly submit the name of the nominee/s which shall represent a Regional level cooperative based in Naga City for appointment by the City Mayor to the NCCDC.

"SECTION 3. - The Council shall have the following functions and powers:

- 1. To formulate policies on various cooperative development undertakings in the City of Naga taking due consideration and observance of the universal cooperative principles as embodied in the Cooperative Code of the Philippines;
- 2. To monitor the implementation of various cooperative development plans and projects of the City of Naga with the end view of harmonizing the same;
- 3. To adopt and operationalize a Cooperative Medium Term Development Plan (CMTDP) of the City of Naga in consultation with concerned sectors in the city;
- 4. To rationalize and ensure the provision of sufficient resources towards the full realization of the cooperative development plans of the city;
- 5. To serve as forum for the discussion and resolutions of various policy issue and concern affecting cooperatives within the city;
- 6. To serve as coordinative mechanism between and among various government and non-government entities and instrumentalities in the pursuit of the aforementioned functions;
- 7. To assess and evaluate application for accreditation of cooperatives and submit recommendations thereon to the Sangguniang Panlungsod Committee on NGO/PO Accreditation.

"SECTION 4. - QUORUM OF THE COUNCIL. - The presence of at least three (3) representatives from the government sector and three (3) representatives from the private sector shall constitute a quorum required for the council to validly transact business in the performance of the functions enumerated under Section 3 thereof.

"SECTION 5. - HONORARIUM. - The members of the Council shall serve without compensation, provided however, that an amount sufficient to defray the reasonable expenses incurred by the private sector representatives in attending meetings and activities of the Council shall be granted Resolution of the Council.

"SECTION 6. - Section 3 of Ordinance No. 95-049 on Implementing Guidelines is reproduced en-toto under this Section.

"SECTION 7. - The Secretariat functions of the DOLECOM as mandated under Section 4 of the Ordinance No. 95-049 shall now be performed by the METRO PESO.

"SECTION 8. - FUNDING. - The appropriation of Twenty Thousand Pesos (P20,000.00) for the annual operation of the council mandated under the Section 5 of Ordinance No. 95-049 is hereby increased to One Hundred Thousand (P100,000.00) pesos per annum and shall be specifically and automatically provided for in the Annual Appropriation Ordinance of the City.

**SECTION 2.** - This ordinance shall take effect immediately upon its approval.
