ORDINANCE NO. 2001-011

AN ORDINANCE FURTHER AMENDING ORDINANCE NO. 93-028 AS AMENDED BY ORDINANCE NOS. 93-030, 98-070 AND 99-089, ENTITLED: "AN ORDINANCE ESTABLISHING AND AUTHORIZING THE GOVERNMENT EMPLOYEES MEDICAL SERVICES FOR ALL NAGA CITY GOVERNMENT EMPLOYEES", BY INCREASING THE DISCOUNTS FOR LINGKOD BARANGAY FOUNDATION MEMBERS AND SENIOR CITIZENS LEAGUE MEMBERS:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - Section 4 of Ordinance No. 93-028 as amended by Ordinance Nos. 93-030, 98-070 and 99-089, entitled: "An Ordinance establishing and authorizing the Government Employees Medical Services for all Naga City Government Employees", is hereby amended by increasing the discounts for Lingkod Barangay Foundation Members and Senior Citizens League Members, now to read as follows:

"SECTION 4. - The following medical benefits under the GEMS are hereby granted to the Naga City Government Employees:

 - o. Fuerza Nagueña sa Maogmang Lugar
 - p. Bugkos Familia sa Naga

- q. Family Welfare Club of Naga City
- r. Farmers Cooperatives & Associations
- s. Core Shelter Beneficiaries
- t. Traditional Birth Attendants Naga City Federation
- u. Naga City Senior Citizens Federation Members

Organization's ID shall be presented by the concerned.
