**ORDINANCE NO. 2001-019**

**AN ORDINANCE FURTHER AMENDING SECTION 4 OF ORDINANCE NO. 93-028 AS AMENDED BY ORDINANCE NOS. 93-030, 98-070, 99-089 AND 2001-011, ENTITLED: "AN ORDINANCE ESTABLISHING AND AUTHORIZING THE GOVERNMENT EMPLOYEES MEDICAL SERVICES FOR ALL NAGA CITY GOVERNMENT EMPLOYEES", BY INCLUDING IN ITS COVERAGE ADDITIONAL LINGKOD BARANGAY FOUNDATION MEMBERS, PERSONS WITH DISABILITIES IN THE CITY OF NAGA, ASSOCIATIONS OF MARKET VENDORS/STALLHOLDERS AT THE NAGA CITY PUBLIC MARKET AND LADIES IN GREEN FOUNDATION OF NAGA CITY:-**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** - Section 4 of Ordinance No. 93-028 as amended by Ordinance Nos. 93-030, 98-070, 98-089 and 2001-011, entitled: "An ordinance establishing and authorizing the Government Employees Medical Services for all Naga city Government Employees" is hereby further amended by including in its coverage additional Lingkod Barangay Foundation Members, Persons with Disabilities in the City of Naga and Associations of Market Vendors/Stallholders at the Naga City Public Market and Ladies in Green Foundation, now to read as follows:

"SECTION 4. - The following medical benefits under the GEMS are hereby granted to the Naga City Government Employees, Lingkod Barangay Foundation Members, Persons with Disabilities, Associations of Market Vendors/Stallholders at the Naga City Public Market and Ladies in Green Foundation of Naga City:

- d. All Persons with Disabilities (PWDs) also known as Disabled Persons who are residents of the City of Naga shall also be granted free consultation, hospitalization, medicines and laboratory examinations at the Naga City Hospital.
- e. NAPMASFED (Naga City Public Market Stallholders Federation)
- f. Ladies in Green Foundation of Naga City

Identification Card issued by their respective Association shall always be presented by the concerned, upon medical consultation in the hospital.

**SECTION 2.** - This ordinance shall take effect upon its approval.
