ORDINANCE NO. 2001-040

AN ORDINANCE AMENDING SECTION 55, AND SECTION 57, ARTICLE XVI OF ORDINANCE NO. 93-049, AS AMENDED, OTHERWISE KNOWN AS “THE TRANSPORT AND TRAFFIC CODE OF NAGA CITY” BY ALLOWING THE EASTBOUND PASSENGER JEEPNEYS TO USE/PARK/LOAD AND UNLOAD PASSENGERS AT THE NEWLY CONSTRUCTED EASTBOUND JEEPNEY TERMINAL AT THE CENTRAL BUSINESS DISTRICT II (CBD II) IN THE CITY OF NAGA, AND FURTHER DEFINING ITS ROUTE, AND BY DEFINING THE RE-ROUTING SCHEME OF INTRA CITY PUBLIC UTILITY JEEPNEYS (PUJS) LEADING TO THE EAST BOUND JEEPNEY TERMINAL AT THE CENTRAL BUSINESS DISTRICT II:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - Section 55, Article XVI of Ordinance No. 93-049, as amended, otherwise known as “The Transport and Traffic Code of Naga City”, is hereby amended by allowing the eastbound passenger jeepneys to use/park/load and unload passengers at the newly constructed Eastbound Jeepney Terminal at the Central Business District II (CBD II) in the City of Naga, and further defining its route, now to read as follows:

“SECTION 55. - INTER-CITY TRAFFIC ROUTES. -

a. Public Utility Jeepneys (PUJ’s) shall take the following routes as herein indicated in Map No. 2 marked as Annex II:

1. From East-Bound

Entrance: Take left turn to Diversion Road (now Roxas Avenue) upon reaching the junction of Concepcion Pequeña (infront of Concepcion Church) then take a right turn towards Naga City Subdivision, then left turn to CBD II road towards the terminal at the back of Saint Joseph School;

Exit: Shall be at the main highway fronting the ALDP (now Robertson Mall) at Diversion Road (now Roxas Avenue).

(See attached Map No. 55-A)

SECTION 2. - Section 57, Article XVI of Ordinance No. 93-049, as amended, otherwise known as “The Transport and Traffic Code of Naga City”, is hereby further amended by defining the re-routing scheme of intra city Public Utility Jeepneys (PUJ’s) leading to the East Bound Jeepney Terminal at the Central Business District II, now to read as follows:

“SECTION 57. - INTRA CITY TRAFFIC ROUTES. -

- a. Public utility Jeepneys (PUJ's)
- b. The new Traffic Re-routing Scheme of all Public Utility Jeepneys (PUJs) leading to the East Bound Jeepney Terminal at the Central Business District II of the City of Naga shall be strictly followed itemized hereunder:
 1. Magsaysay Loop Service “A” passenger jeepneys traveling from Magsaysay Avenue going to Roxas Ave. shall enter turn right to Carnation St., Naga City Subd., turn left to service road to Eastbound Jeepney Terminal and loading and/or unloading passengers, then proceed to New Central Bus Terminal CBD II then exit in front of the ALDP, then turn right along Roxas Avenue, turn right to Tabuco in going to CBD I then to Peñafrancia and Magsaysay Avenue. (See Map No. 57-A)
 2. Magsaysay Loop Service “B” passenger jeepneys traveling from Magsaysay Avenue shall turn left to Peñafrancia in going to CBD I, then going to Tabuco, left to Roxas Avenue, left to service road entrance in front of ALDP and loading and/or unloading passengers at the New Central Bus Terminal and proceed to Eastbound Jeepney Terminal, then exit turn right to Carnation St., turn left to Roxas Ave. then to Magsaysay. (See Map No. 57-B)
 3. Multi-Cab Loop Service “G” passenger jeepneys traveling from Dayangdang shall turn right to Del Pilar St., left turn to Mayon Ave., left turn to Panganiban, right turn to Sampaguita St., Naga City Subd., right turn to Azucena St., turn left to service road to Eastbound Jeepney Terminal, then to New Central Bus Terminal CBD II and exit at Panganiban Ave., then left turn to Lerma St., then turn to Gen. Luna back alley, right turn to Caceres St., proceed to Dinaga, right turn to Panganiban, then left to Blumentritt then to Dayangdang. (See Map No. 57-C)
 4. Multi-Cab Loop Service “H” passenger jeepneys traveling from Dayangdang to Blumentritt shall turn right to Panganiban left turn to Elias Angeles St. to Caceres St., left to General Luna St., proceed to Tabuco Bridge left to PNR Road, left to Balintawak, right turn to Lerma St., right to Panganiban, right turn to service road, loading and/or unloading in front of New Central Bus Terminal CBD II, then proceed to Eastbound Jeepney Terminal, exit at Naga City Subd. Road then left turn to Carnation St., right turn to Azucena, left turn to Sampaguita, left to Panganiban right turn to Mayon, right to Apo Drive, to Ma. Cristina St., then turn right to Del Pilar then turn left to Dayangdang. (See Map No. 57-D)
 5. Multi-Cab Loop Service “I” passenger jeepneys traveling along Roxas Avenue shall turn left to service road entrance in front of ALDP, load/unload in front of New Central Bus Terminal, then proceed to Eastbound Jeepney Terminal, load/unload exit at service road left to Carnation St., Naga City Subd., right Azucena St., left to Sampaguita St., left turn to Panganiban Drive, right to Peñafrancia, left to Arana, left to J. Hernandez St., right to Zamora, then left to Tabuco-Sabang Bridge towards Roxas Ave. then to CBD II. (See Map No. 57-E)

6. Naga-Del Rosario via Diversion passenger jeepneys traveling from Del Rosario shall turn left to Roxas Ave., then right to Carnation, Naga City Subd., turn to left towards Eastbound Jeepney Terminal, proceed to New Central Bus Terminal and exit at the service road in front of the ALDP, then right turn to Roxas Ave. to Tabuco then to General Luna St., left to P. Burgos St., left to J. Hernandez, left to Zamora, then right turn to Tabuco, left turn to Roxas Ave., then pass again at the CBD II Terminals. (See Map No. 57-F)
7. Naga-Del Rosario via Diversion and via LCC passenger jeepneys shall take the same route of the above-cited (#G) jeepneys except upon reaching J. Hernandez St., shall turn right to Abella St., then left to Felix Plazo St. the load/unload at LCC then exit at Sabang-Tabuco Bridge pass again at said Terminals then out. (See Map No. 57-G)
8. Naga-Concepcion via Panganiban passenger jeepneys terminal from Concepcion Grande jeepney going via CBD shall turn left to Sampaguita, Naga City Subd., turn right to Eastbound Jeepney Terminal, then exit and left turn to Panganiban, right to Peñafrancia Ave., left to Arana, left to J. Hernandez Ave., left to Zamora to Gen. Luna back alley, right to Padian then Dinaga, right to Panganiban Drive, right to service road going to Terminal then exit at Azucena St., turn to left then right to Panganiban Drive then to Concepcion. (See Map No. 57-H)
9. Naga-Del Rosario via Panganiban and via LCC passenger jeepneys. They must follow the same route of the above Item No. 8 except upon reaching corner J. Hernandez. Shall turn right to Abella St., left to Felix Plazo then load/unload passengers in front of LCC Complex, then left to Bagong Sirang.

SECTION 3. - SEPARABILITY CLAUSE. - All ordinances, resolutions, orders, rules and regulations of part thereof inconsistent with any provision of this ordinance, are hereby repealed, amended and/or modified accordingly;

SECTION 4. - This ordinance shall take effect upon its approval and after publication in a newspaper of local circulation.
