ORDINANCE NO. 2001-061

AN ORDINANCE SIMPLIFYING REVENUE COLLECTION FROM CERTAIN PROPERTIES USED FOR VENDING DURING THE PEÑAFRANCIA FIESTA AND AUTHORIZING HIS HONOR, THE CITY MAYOR TO ENTER INTO LEASE OR OTHER AGREEMENTS WITH PROPERTY OWNERS FOR THE PURPOSE AND FOR THIS PURPOSE AMENDING ORDINANCE NO. 2001-057:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - GENERAL PROHIBITION. - Vending during Peñafrancia Fiesta in public places such as sidewalks, plazas, sidestreets, and alleys is prohibited except as provided for under the Sidewalk Vending Regulatory Ordinance (Ord. No. 2001-055).

SECTION 2. - GRANT OF AUTHORITY TO THE CITY MAYOR. - (a) For purposes of simplifying revenue collection, the City Mayor is hereby authorized to enter into lease or other agreements with private property owners and, through an awards committee created under this ordinance, bid out the use of such property to interested parties who will manage the actual operation of the same as vending areas.

SECTION 3. - BIDS AND AWARDS COMMITTEE. - A Bids and Awards Committee is hereby created with the following composition:

Chairman:	City Mayor
Co-Chairman:	Chairman, Sangguniang, Committee on Market Affairs
Members:	City Treasurer
	City Legal Officer
	Market Superintendent
	Representative of the Naga City
	People's Council

SECTION 4. - PROCEDURE. - The Bids and Awards Committee shall be guided by a fair and transparent bidding and awards procedures, which shall be prepared and submitted by the Committee to the City Mayor for final approval immediately.

SECTION 5. - NATURE OF THE WINNING BID. - The amount of the winning bid shall be deemed to represent the Business Tax, Mayor's Permit Fee, Sanitary Permit Fee, Garbage Fee and Fire Inspection Fee of the occupants of the entire property operated as a vending area. No other taxes or fees may be collected by the city government from the vendors within the same property.

SECTION 6. - BARANGAY CLEARANCE. - By virtue of Section 152 of the Local Government Code, the barangays may impose Barangay Clearance Fees on the operator and vendors who will occupy the property.

SECTION 7. - PENALTY CLAUSE. - Any person or persons found guilty of violating Section 1 of this ordinance shall be penalized by a fine of not more than Five Thousand (P5,000.00) Pesos or imprisonment of not exceeding one (1) year or both such fine and imprisonment at the discretion of the court.

SECTION 8. - REPEALING CLAUSE. - All orders, resolutions, ordinances, rules and regulations or parts thereof which are inconsistent with any provision of this ordinance are hereby amended, repealed and/or modified accordingly.

SECTION 9. - EFFECTIVITY. - This ordinance shall take effect upon its approval and after publication in a newspaper of local circulation.

SECTION 10. - This ordinance amends Ordinance No. 2001-057, S. 2001.
