**ORDINANCE NO. 2001-092**

**AN ORDINANCE AMENDING SECTION 20 OF ARTICLE V, SECTION 34 OF ARTICLE VIII AND SECTION 35 OF ARTICLE 1X OF ORDINANCE NO. 92-032, S. 1992, OTHERWISE KNOWN AS THE “NAGA CITY LIVESTOCK ORDINANCE”, AND BY ADDING ANOTHER ARTICLE THERETO SPECIFICALLY ON INCENTIVES:-**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** - SECTION 20, Article V of Ordinance No. 92-032, is hereby amended, now to read as follows:

“ARTICLE V. - REGISTRATION, LICENSING AND FEES. -

X X X X X X X X X X X

“SECTION 20. - FEES. - The following shall be collected from farmers, dealers and handlers involved in the local livestock industry.

A. For services extended by the market

| f. Hauling Fee. This shall be computed based on live weight and distance Carabao/Cattle                             |                                  |

| Hog   | P0.10 per kilogram per kilometer |
| g. Registration for Dealers/Traders   | P100.00 per year                 |

B. A shipper’s fee shall be imposed upon shippers or “viajero” on a per head basis, pursuant to Executive Order No. 626, using the following rates:

**SECTION 2.** - Section 34, Art. VIII of Ordinance No. 92-032, is hereby amended, now to read as follows:

**ARTICLE VIII. - P E N A L T Y. -**

“SECTION 34. - PENALTY. - Any farmer, dealer or handler or any other individual engaged in livestock trading who violates any provision of this ordinance shall be levied a fine of not more than P1,000.00 on the first offense; P1,000.00 up to not more than P2,000.00 on the second offense; and P2,000.00 up to not more than P5,000.00 and cancellation of license in case of farmers or other individuals on the third and final offense, as deemed appropriate by the Management”.

**SECTION 3.** - SECTION 35, Art. IX of Ordinance No. 92-032, is hereby amended, now to read as follows:

**ARTICLE IX. - FINAL PROVISIONS. -**

“SECTION 35. - TRANSITORY PROVISION. - Upon establishment of the Market, there shall be a grace period one (1) month on shipper’s fee one (1) month on commission, and one (1) month on entrance and yardage fees to promote market services, beginning from the first day of its operation”.

**SECTION 4.** - Article X on Incentives is hereby added to Ordinance No. 92-032, to read as follows:

**ARTICLE X. - INCENTIVES. -**

An Incentive Fee shall be granted to farmers and raisers from the 27 barangays of the City of Naga, under the following rates:

**SECTION 5.** - This ordinance shall take effect upon its approval and after three (3) consecutive publications in a newspaper of local circulation.
