ORDINANCE NO. 2002-024

AN ORDINANCE EXERCISING THE POWER OF EMINENT DOMAIN OF THE CITY GOVERNMENT OF NAGA OVER A PARCEL OF LAND COVERED BY TCT NO. 32460 REGISTERED IN THE NAME OF MUN. RURAL BANK OF LIBMANAN (CAM. SUR), INC. LOCATED AT ARAGO SUBDIVISION, TRIANGULO, NAGA CITY FOR PURPOSES OF ROAD CONSTRUCTION PROJECT AT ARAGO SUBDIVISION AND AUTHORIZING THE CITY MAYOR TO FILE THE NECESSARY EXPROPRIATION PROCEEDINGS IN COURT AND FURTHER AUTHORIZING THE CITY LEGAL OFFICER TO AMEND THE COMPLAINT IN THE CITY OF NAGA VS. MANOLITO GAGALAC, ET AL., SPECIAL CIVIL CASE NO. 2002-0030:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - The City of Naga is hereby exercises its power of eminent domain over a parcel of land covered by TCT No. 32460 registered in the name of Mun. Rural Bank of Libmanan (Cam. Sur), Inc. located at Arago Subdivision, Triangulo, Naga City which shall be affected by the road construction project at Arago Subdivision specifically described as follows:

“Lot 7-A, Block 11

“A parcel of land designated as Lot 7-A, being a portion of Lot 7, Block 11, (LRC), Psd-197665, situated in Barangay Triangulo, City of Naga, Island of Luzon, bounded on the SW, along line 5- by Lot 6, Block 11 and 1-2 by Lot 5, Block 11, on the NW, along line 2-3, by Lot 7-B, Block 11, on the NE, along line 3-4, by Road Lot 2, and on the SE, along line 4-5, by Lot 8, Block 11. xxx containing an area of SEVENTY-FOUR (74) SQUARE METERS.”

SECTION 2. - The City Mayor is hereby authorized to file the necessary expropriation proceedings in court to effect this exercise.

SECTION 3. - The City Legal Officer is hereby authorized to amend the complaint in the City of Naga vs. Manolito Gagalac, et al., Special Civil Case No. 2002-0030.

SECTION 4. - This ordinance shall take effect upon its approval.
