**ORDINANCE NO. 2003-041**

**AN ORDINANCE AMENDING SUB-SECTION 10.1 AND FURTHER AMENDING SECTION 13 OF ORDINANCE NO. 97-092, ENTITLED: "AN ORDINANCE REGULATING THE OWNERSHIP, CARE AND UPKEEP OF ANIMALS IN THE CITY OF NAGA", AS AMENDED:-**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** - Sub-section 10.1 of City Ordinance No. 97-092, is hereby amended, now to read as follows:

"SECTION 10.1 - IMPOUNDING FEES. - The following fees per day shall apply:

For each horse, cattle, or carabao	P 200.00
For each dog	200.00
For each pig, goat, sheep or other four-legged animals	75.00
For each cat	50.00
For each fowl	5.00

In addition, the owner of the animal shall pay the amount of ten pesos (P 10.00) per day for animal classified under a, b, c and d and five pesos (P 5.00) per fowl per day until such day that he redeems the impounded animals, subject to the limitation under Sec. 64.3 of Ordinance No. 92-048, s. 1992, as amended. The impounding fees shall be paid to the City Treasurer or to the Barangay Treasurer as the case may be."

**SECTION 2.** - Section 13 of City Ordinance No. 97-092, as amended, is hereby further amended, now to read as follows:

"SECTION 13. - PENALTY CLAUSE. - Any person who shall violate any of the provisions of this ordinance shall be penalized with a fine of not less than two thousand pesos (P 2,000.00) or imprisonment of not less than thirty (30) days, but not more than six (6) months, or both fine and imprisonment at the discretion of the court; provided that when the violation involves a dog, the penalty shall be five thousand pesos (P5,000.00) and/or imprisonment of one (1) year at the discretion of the court. The fine shall be imposed in accordance with the provisions of ADMINISTRATIVE FINES AND PENALTIES or City Ordinance No. 95-093."

**SECTION 3.** - EFFECTIVITY. - This ordinance shall take effect immediately upon its approval.
