**ORDINANCE NO. 2004-046**

**AN ORDINANCE AMENDING CITY ORDINANCE NO. 2003-013 BY GRANTING INCENTIVES TO ALL ENVIRONMENT ENFORCES AUTHORIZED THEREIN: -**

Sponsor: Hon. Simeon F. Adan

Be it ordained by the Sangguniang Panlungsod in session assembled that:

**WHEREAS**, there is an urgent need for those environment enforcers authorized under the above mentioned City Ordinance who are not performing their duties to be given honorarium for their services; and

**WHEREAS**, the honorarium that may be granted herein can be sourced from the fines and penalties that may be collected from the violators they have apprehended to have violated the provisions of the same above cited main ordinance; BE IT THEREFORE ordained the following amendments to City Ordinance No. 2003-013, viz:

**SECTION 1.** - SECTION 5.11 of City Ordinance 2003-013 known as BANTAY KAPALIBOTAN SA MAOGMANG LUGAR, shall be amended by adding thereto a new provision on ENVIRONMENT ENFORCERS to be designated as Sections 5.11.a to 5.11.d as follows:

“SECTION 5.11.a. - INCENTIVES TO DEPUTIZED OFFICERS. - All Deputized Officers enumerated under Section 4.2 of above cited City ordinance No. 2003-013 shall be given honorarium for their services as such ENVIRONMENT ENFORCES corresponding to twenty five (25%) of the Total fined and penalties imposed upon and collected from the violators he/she has actually apprehended.

“SECTION 5.11.b. The monetary incentives herein above to be granted shall be collected from the mother unit he/she belongs after every fifteen (15) days of service and only after said enforcer has submitted all reports on his apprehension have been submitted as provided under Sections 5.5. to 5.10 of the main ordinance.

“SECTION 5.11.c. Twenty five per cent (25%) of the total fines and penalties collected herein shall accrue to the mother unit of the ENVIRONMENT ENFORCER concerned which fund shall be constituted as special trust fund of the said mother unit to be allotted by said mother unit for clean and green projects. The remaining fifty per cent (50%) of such collection shall be forwarded by the said mother unit of the ENVIRONMENT ENFORCER to be City Treasurer who in turn shall keep said funds in trust for expenses of the ENRO department specifically for its Garbage collection and disposal activities subject to the Usual auditing procedures.

SECTION 5.11.d. The provisions under this incentive System for environment enforcers shall amend and modify The provisions of Section 8 B.2.4 in the matter or sharing The proceeds of fines and penalties therein collected but shall not alter or

amend provisions of Section 6 of City Ordinance No. 2003-024 on cleaning of vacant lots its Own specific purpose.

**SECTION 2. - REPEALING OR AMENDATORY CLAUSE.** - Any provisions of existing Ordinance, rules and regulations and or parts thereof inconsistent to the provisions of this amendatory ordinance are hereby repealed and or modified accordingly.

**SECTION 3. - EFFECTIVITY.** - This Ordinance shall take effect immediately upon approval.
