**ORDINANCE NO. 2004-050**

**AN ORDINANCE GRANTING AMNESTY TO ALL OWNERS OF TRIMOBILE WHOSE TRIMOBILE FRANCHISE WAS ACQUIRED IN VIOLATION OF THE PROVISIONS OF APPROVED CITY ORDINANCE NO. 99-049 AS AMENDED BY ORDINANCE NO. 2001-075 AND ORDINANCE NO. 2003-038 SUBJECT TO COMPLIANCE OF ADDITIONAL REQUIREMENTS AND UPON PAYMENT OF THE TRANSFER FEE:-**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1. – PURPOSES.** The purpose of this ordinance is to legitimize all owners of trimobile units whose trimobile franchise was acquired without proper compliance of the provisions under approved City Ordinance No. 99-049 as amended by 2001-075 and 2003-038.

**SECTION 2. – COVERAGE.** This ordinance shall cover all trimobile operators whose trimobile unit and/or franchise was acquired prior to the effectivity of this Ordinance. All acquisition or transfer of trimobile franchise after the effectivity of this ordinance is excluded in this amnesty.

**SECTION 3. RULES AND GUIDELINES.** In addition to the qualification requirements provided under Section 3 of Ordinance No. 99-049, Section 2 of Ordinance No. 2001-075 and of Section 1 of Ordinance No. 2003-038, all trimobile operators/franchisee shall present the following, to wit:

1. Proof of transfer showing that the transfer was made within the period covered;
2. Both the transferee and the transferor must be residents of Naga City.

**SECTION 4.** In addition to the requirements provided in the preceding Section, he/she shall execute an AFFIDAVIT OF UNDERTAKING categorically declaring that no subsequent transfer or disposition shall be executed involving his/her trimobile franchise other than those allowed by existing rules and regulations.

**SECTION 5.** All holders of a valid trimobile franchise who subsequently transferred residence outside the territorial jurisdiction of Naga City may be allowed to renew its franchise only for a period until year 2005 and shall automatically be deemed cancelled effective 2006.

**SECTION 6. TRANSFER FEE. –** All applicants under this amnesty ordinance shall be assessed a transfer fee of P3,500.00 which shall be paid before the approval of his application.

**SECTION 7. PERIOD OF AVAILMENT.** – All holders of a trimobile franchise covered by this amnesty ordinance is given a period until December 31, 2004 to apply otherwise, his/her franchise shall be automatically be cancelled effective January 1, 2005.

**SECTION 8. EFFECTIVITY.** – This ordinance shall take effect upon its approval and publication in a newspaper of local circulation.
