## **ORDINANCE NO. 2004-084**

AN ORDINANCE FURTHER AMENDING ORDINANCE NO. 93-049, OTHERWISE KNOWN AS "THE TRANSPORT AND TRAFFIC CODE OF NAGA CITY", SPECIFICALLY SECTIONS 117 THEREOF:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** – Sections 117 of Ordinance No. 93-049, otherwise known as "The Transport and Traffic Code of Naga City" is hereby amended, now to read as follows:

SECTION 117. – UNIT IDENTIFICATION AND PASSENGER RATE. – Motorized trimobiles/tricycles operating in the city for public utility shall prominently display in the front and back outside portion of the trimobile sidecar, a <u>permanent</u> city registration <u>plate measuring 12 inches x 18 inches</u> and the same number inside the sidecar in front of the passenger <u>measuring 8 inches by 12 inches</u> and the name and address of the operator or franchise holder <u>shall be printed below the said plate number</u>. This permanent City Registration Plate shall be paid at cost to the City Treasurer's Office (CTO) by the operator or franchise holder. Upon renewal, the Trimobile Task Force shall issue a sticker to be paid at cost to the CTO by the operator and the same shall be posted on the designated space in the plate. In case of lost, the operator or franchise holder is required to submit an Affidavit of Loss and pay at cost to the CTO prior to the issuance of a new plate. x x x x x

"In any case or event that the Trimobile Plate Number is lost or damaged, the supplier/contractor shall produce the same plate at a cost and surrender the damaged plate".

"<u>Likewise</u>, the operator will provide the frame (front & rear) for the <u>Trimobile Plate Number</u>".

The background color of the Plate shall reflect the color-coding scheme per Ordinance No. 93-026 (INTRAP Ordinance).

**SECTION 2**. – This ordinance shall take effect on January 1, 2005 and after three (3) consecutive publications in a newspaper of local circulation.
