**ORDINANCE NO. 2004-099**

**AN ORDINANCE FURTHER AMENDING ORDINANCE NO. 93-049, S. 1993, OTHERWISE KNOWN AS THE “TRANSPORT & TRAFFIC CODE OF NAGA CITY” AS AMENDED BY ORDINANCE NO. 2001-086 SPECIFICALLY SECTION 134 THEREOF, AS AMENDED BY ORDINANCE NO. 2002-010, BY ADDING TWENTY FIVE (25) UNITS OF PADYAK TO THE STA. CRUZ PADYAK OPERATORS AND DRIVERS ASSOCIATION (STC-PODA) TOTALLING THE NUMBER TO FORTY SIX (46) PADYAK UNITS TO OPERATE WITHIN THE ROUTE HEREIN SPECIFIED:-**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** – Ordinance No. 93-049, s. 1993, otherwise known as the “Transport & Traffic Code of Naga City”, as amended by Ordinance No. 2001-086, as amended by Ordinance No. 2002-010, is hereby further amended by adding Twenty-Five (25) units of padyak to the Sta. Cruz Padyak Operators and Drivers Association (STC-PODA) totaling the number to Forty Six (46) padyak units to operate within the route herein specified, now to read as follows:

**“SECTION 134. – Registration:**

6. Each padyak for hire shall be allowed to ply only a specific route area which shall be identified according to the area covered by the accredited association.

**SECTION 2.** - The following shall be observed in the distribution or filling-up of the additional 25 units:

- the 25 slots shall be raffled among the 37 applicants recommended by the Padyak Association and the Barangay Council.

- To qualify in the raffle, the following criteria shall be observed:
  1. Applicant must be a resident of Barangay Sta Cruz;
  2. The applicant has no existing padyak operating in Sta Cruz or in any Barangay in Naga City;
  3. Has no record with the (TTMO) that he is a former padyak operator but sold his unit;
  4. The raffle shall be conducted by the Committee on Public Utilities with the presence of all concerned.

**SECTION 3.** – This ordinance shall take effect upon its approval and after publication in a newspaper of local circulation.
