## **ORDINANCE NO. 2005-006**

AN ORDINANCE AMENDING ORDINANCE NO. 93-049, OTHERWISE KNOWN AS THE "TRANSPORT AND TRAFFIC CODE OF NAGA CITY", AS AMENDED, SPECIFICALLY SECTIONS 144 AND 146, THEREOF, BY FIXING THE FEE AND PROVIDING WARRANTY PERIOD OF REPLACEMENT/REPRODUCTION OF IDENTIFICATION CARD (I.D.):-

Sponsor: Hon. Jose L. Grageda

Be it ordained by the Sangguniang Panlungsod of the City, that:

**SECTION 1.** Sections 144 and 146 of Ordinance No. 93-049, otherwise known as the "Transport and Traffic Code of Naga City," as amended, now to read as follows:

## **"SECTION 144 -**

e.) date issued and expiration date"

"SECTION 146. - <u>Identification Card issued in accordance with this Code shall</u> be valid and effective for a period of three (3) years from the date of its issuance. For this purpose, the expiration date of every I.D. issued should clearly be indicated prominently on its face"

SECTION 2. - Fees, Production and reproduction of Identification Card or I.D.

"SECTION 146-A. - The fee for securing I.D. is hereby fixed at Fifty Pesos (P50.00) to be paid at the Naga City Treasurer's Office.

SECTION 146-B.- Processing - All application for issuance of I.D. (new or renewal) shall be submitted before the Transport and Traffic Management Office (T&TMO). Attached to the application form are the following documents, to wit:

- 1) Barangay Clearance
- 2) Community Tax Receipt
- 3) Photocopy of valid professional Driver's License
- 4) 2 x 2 picture

Applicant shall state categorically whether the applicant is a regular or substitute driver. Application form submitted should by the applicant and the operator, the same should be subscribed attesting to the truth and correctness of all the information provided.

SECTION 146-B. - Warranty – For this purpose the warranty mentioned, is only limited to replacement and re-lamination of the I.D. previously issued in accordance with this Ordinance subject however to the following requirements; to wit:

- 1) The original I.D. must be presented or surrendered personally to the (T&TMO);
- 2) The I.D. is still valid and effective;
- The applicant has no pending or unpaid/unsettled fine imposed by accordance with the ordinance or administrative fines.

SECTION 146-C- Period of Warranty – All I.D. issued shall have a warranty period of 6 months from the date of its issuance.

**SECTION 3.** Effectivity - This ordinance shall take effect upon its approval and after publication in a newspaper of local circulation.
