**ORDINANCE NO. 2005-045**

**AN ORDINANCE AMENDING SECTION 4 AND SECTION 5 OF ORDINANCE NO. 2003-037, ENTITLED: “ORDINANCE REGULATING THE NAMING OF, OR THE INSCRIPTION OR PUTTING OF NAME ON, ANY PERMANENT STRUCTURE BUILT USING GOVERNMENT FUNDS, WHETHER OR NOT SITUATED IN GOVERNMENT-OWNED PROPERTY, WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF NAGA”:-**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1.** Section 4 of Ordinance No. 2003-037 is hereby amended, now to read as follows:

**“SECTION 4. DEFINITION OF TERMS.** – As used in this Ordinance, the following terms shall mean:

- d. responsible for the enforcement of the provisions of the National Building Code of the Philippines (P.D. 1096) as well as of the implementing rules and regulations issued therefor. He is the official charged with the duties of issuing building permits.

He shall have overall administrative control and/or supervision over all work pertinent to buildings within his area of responsibility and shall have direct charge of processing of all building permit applications on the basis of land-use and architectural, structural and geodetic (line and grade), sanitary and plumbing, electrical, mechanical and fire as well as other standard requirements, rules and regulations promulgated in accordance with the National Building Code.

He shall review and evaluate the design, plans and programs with the corresponding specifications, estimates and other necessary building documents of all building projects under his charge.

- e. Remove – means to physically erase, delete, deface, paint over, detach/plaster or cover permanently the name placed, painted or inscribed on the structure, without compromising the structural integrity and aesthetic value of the subject structure.”

**SECTION 2.** Section 5 of Ordinance No. 2003-037 is hereby amended, now to read as follows:

**“SECTION 5. COMPLIANCE PROCEDURE.** – For effective implementation of this ordinance, the compliance procedure herein established shall be followed before any permanent structure constructed or initiated by or through the local government unit

or the national government or any of its departments, agencies and instrumentalities, shall be undertaken within the territorial jurisdiction of the City of Naga, as follows:

- g) The Building Official of the City Government of Naga is deputized to enforce this Ordinance, and for this purpose he is hereby given the authority to deny the issuance of occupancy permit to an applicant found to be violating the provisions of this Ordinance. In connection with this authority, the Building Official is hereby authorized to remove the name inscribed, in violation of this Ordinance, on any permanent structure as defined in Section 4(a) of this Ordinance, at the expense of the violator.”

**SECTION 3. EFFECTIVITY.** – This ordinance shall take effect immediately upon its approval.
