## **ORDINANCE NO. 2006-009**

AN ORDINANCE FORMALLY AND OFFICIALLY CONFIRMING THE PATRIMONIAL CHARACTER AND CLASSIFICATION OF THE CENTER ISLAND LOCATED AT THE CORNER OF P. BURGOS ST. AND GENERAL LUNA ST. WITHIN THE CENTRAL BUSINESS DISTRICT 1:-

Be it ordained by the 8<sup>th</sup> Sangguniang Panlungsod of Naga, that:

**SECTION 1.-** CONFIRMATION OF THE WITHDRAWAL FORM PUBLIC USE. - The previous withdrawal of the center island as described below, from public use is here officially and formally confirmed upon the effectivity of this Ordinance.

**SECTION 2.** CLASSIFICATION BY ACTUAL USE.- The Patrimonial character and classification of the center island described under Section 2 hereof, located along the corner of P. Burgos St. and General Luna St. within the Central Business District-1 is recognized and therefore may be lawfully used for other purposes for which other real property belonging to the City.

**SECTION 3.** <u>DESCRIPTION.</u> – The Patrimonial property (center island) of the City located at corner P. Burgos St. and General Luna St. within the Central Business District-1 containing an area of TWENTY ONE SQUARE METERS 921 sq.m.) more or less and is more particularly described as follows, to wit:

## (STREET ISLAND)

"A parcel of land (Street Island) located at Barangay Sta. Cruz, City of Naga containing an area of TWENTY ONE SQUARE METERS (21 sq.m.) more or less; Bounded as follows, along lines:
