AN ORDINANCE AMENDING ORDINANCE NO. 2003-088, AS AMENDED BY ADDING
ADDITIONAL PROVISION THERETO AND ALLOWING THE PASSENGER JEEPNEYS PLYING
THE CANAMAN-NAGA AND MAGARAO-NAGA ROPUTES TO ENTER THE CBD 1 TO UNLOAD
PASSENGERS:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga,
that:

SECTION 1. - Ordinance No. 2003-088 as amended is hereby amended
by adding additional provisions thereto and by allowing the passenger
jeepneys plying the Canaman-Naga and Magarao-Naga routes to enter
the CBD I to unload passengers along Elias Angeles St., now to read
as follows:

"CANAMAN-NAGA ROUTES

ENTRANCE: After entering the city boundary at Bagumbayan Norte,
PUJ's shall pass by Bagumbayan Street, proceed to Elias
Angeles St., then turn right to Arana St. then turn
right to Barlin St. turn right to P. Diaz St. and
turn left to Elias Angeles then proceed to the
Integrated Northbound Terminal.

During Tuesday and Wednesdays - PUJs shall be allowed to
enter the CBD I (24 hours) to unload passengers. On other
days not provided herein, PUJ's shall strictly observe the
prescribed time to unload passengers from 6:00 P.M. up to the
following morning but not beyond 8:00 A.M.

During Saturday and Sundays - PUJ's can enter CBD I to
unload passengers anytime of the day, but must immediately
proceed to the Northbound Terminal.

MAGARAO- NAGA ROUTE

ENTRANCE: After entering the boundary at Bagumbayan Norte, PUJ's
shall pass by Bagumbayan Street, proceed to Elias
Angeles St., then turn right to Arana St. then turn
right to Barlin St., turn right to Dimasalang St. and
turn left to Elias Angeles then proceed to the
Integrated Northbound Terminal.

During Mondays and Fridays PUJ's are allowed to enter the CBD I (24 hours) to unload passengers. On other days not provided herein PUJ's shall strictly observed the prescribed time to unload passengers from 6:00P.M. up to the following morning but not beyond 8:00 A.M.

During Saturdays and Sundays - PUJ's plying these routes shall observed the entrance route of Canaman Naga Route."

SECTION 2. - Penalty. - Penalties for violation thereof shall be as follows:

1 st Offense	-	P 300.00
2 nd Offense	-	500.00
3 rd Offense	-	1,000.00

The Sangguniang Panlungsod shall inform the organization to which the driver violator belongs, and may suspend or cancel these privileges for repeated violations.

SECTION 3. - Separability Clause. - If for any reason, any provision, portion or part of this ordinance found to be inconsistent with any law, order on registration, other provisions or part/s thereof not so affected remain be in full force and effect.

SECTION 4. - Repealing/Amendatory Clause. - All ordinances, rules and regulations or part/s thereof, which are inconsistent or in conflict with the provisions of this ordinance are hereby repealed, amended and/or modified accordingly.

SECTION 5. - Effectivity. - This ordinance shall take effect upon its approval and upon publication in a newspaper of local circulation.
