## ORDINANCE NO. 2007-001

## AN ORDINANCE DECLARING THE STAIRLANDING LOCATED AT BARANGAY SABANG, NAGA CITY, AS THE OFFICIAL WHARF/DOCKING AREA IN THE CITY OF NAGA FOR ALL KINDS OF MOTORIZED BOAT AND BANCE PLYING THE BICOL RIVER, IMPOSING WHARFAGE FEE FOR THE USE THEREOF, AND FOR OTHER PURPOSES:

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. Wharf or docking Area. - The stair landing located at SPUKOI Relocation Site at Barangay Sabang, Naga City is hereby declared as the Official Wharf or Docking area for all kinds of Motor Boat and Banca ferrying passengers and cargoes to an from the City of Naga.

SECTION 2. Imposition of Fees. - The following wharfage fees
are hereby imposed for the use of the Wharf/Docking Area:

Provided, that no fee shall be collected for hand carried baggage of passengers and other personal belongings, and cargoes consisting of One (1) sack rice, palay or rice bran (ata) and One Hundred (100) nipa shingles.

SECTION 3. Operation and Management of the Wharf/Docking Area. - The Barangay Council of Sabang, thru its Punong Barangay or Authorized Official shall operate and maintain said facility. The Barangay may secure assistance from the City Government of Naga for the construction of the necessary facilities needed to ensure the safety of passengers and crew, and the barangay personnel manning such wharf.

SECTION 4. - Collection and Sharing of Wharfage Fee. - a) the Barangay Treasurer of Sabang or his/her duly authorized collector shall collect all fees, issue official receipt or cash ticket, and to remit all such collections to the Office of the City Treasurer not later than every Friday of the week. b) the collection of wharfage Fee shall be shared by the City Government of Naga and the Barangay Government of Sabang. As follows:

1. Seventy Five Percent (75%) shall accrue to Barangay Government of Sabang.

2. Twenty Five (25%) shall accrue to the City Government of Naga.

c) The City Accountant of the City of Naga shall, at the end of each month, credit to the account of Barangay Sabang, Naga City, its share from the total collection of Wharfage Fee.

**SECTION 5. Penalty Clause.** - The following fine shall be imposed on any person violating the provisions of this ordinance.

If the violation is committed by an official or employee of the government, in addition to the fine imposed herein, he/she shall be dealth with administratively in accordance with existing laws.

**SECTION 6. Effectivity.-** This ordinance shall take effect upon its approval and Fifteen (15) days after publication in a local newspaper of general circulation.
