

ORDINANCE NO. 2009-087

AN ORDINANCE FURTHER AMENDING SECTIONS 111 AND 119 OF ARTICLE XXV OF ORDINANCE NO. 93-049, ENTITLED "AN ORDINANCE CODIFYING THE TRANSPORT AND TRAFFIC ORDINANCES IN THE CITY OF NAGA" AS AMENDED, OTHERWISE KNOWN AS THE "TRANSPORT AND TRAFFIC CODE OF NAGA CITY", BY PROVIDING A SCHEME FOR THE ANNUAL REGISTRATION OF MOTORIZED TRICYCLES OR TRIMOBILES FOR HIRE AND NOT FOR HIRE IN THE CITY OF NAGA:-

WHEREAS, it has been observed that despite the deadline prescribed under the existing ordinances for the annual registration of the Motorized Tricycles or Trimobiles, several operators are seeking renewal of their Mayor's Permit to operate resulting to delayed processing of their applications;

WHEREAS, every year before such deadline, trimobile operators are lobbying for the extension of renewal of Mayor's Permit to operate a motorized tricycle or trimobile;

WHEREAS, possibly the reason why operators are regularly seeking the extension for the renewal of Mayor's Permit to operate these motorized tricycles or trimobiles is the absence of a scheme to be followed for their annual registration;

WHEREAS, to remedy this prevailing situations, there is a need to provide a scheme for an orderly annual registration of motorized tricycles or trimobiles in the City of Naga.

NOW THEREFORE,

Be it ordained by the Sangguniang Panlungsod of the City of Naga assembled, that:

SECTION 1. Section 111 of Article XXV is hereby amended, now to read as follows:

"ARTICLE XXV - MOTORIZED TRICYCLES AND TRIMOBILES

SECTION 111. Franchising and Registration and Mayor's Permit. All motorized tricycles or trimobiles operating in the city for hire or not for hire must possess a valid franchise to operate and a Mayor's Permit to be secured from the City Government.

The Trimobile Franchise shall be for a period of Three (3) years, while the Mayor's Permit has to be secured annually by the operator.

All motorized tricycles or trimobiles for hire and not for hire bearing plates who's ending numbers of their assigned

numeric code shall pay Mayor's Permit opposite to their assigned month schedule that shall not exceed the end of their assigned month, to wit:

- Ending "1" shall renew the registration and pay Mayor's Permit not later than January 31 of the year;
- Ending "2" shall renew the registration and pay Mayor's Permit not later than February 28 of the year;
- Ending "3" shall renew the registration and pay Mayor's Permit not later than March 31 of the year;
- Ending "4" shall renew the registration and pay Mayor's Permit not later than April 30 of the year;
- Ending "5" shall renew the registration and pay Mayor's Permit not later than May 31 of the year;
- Ending "6" shall renew the registration and pay Mayor's Permit not later than June 30 of the year;
- Ending "7" shall renew the registration and pay Mayor's Permit not later than July 31 of the year;
- Ending "8" shall renew the registration and pay Mayor's Permit not later than August 31 of the year;
- Ending "9" shall renew the registration and pay Mayor's Permit not later than September 30 of the year; and
- Ending "0" shall renew the registration and pay Mayor's Permit not later than October 31 of the year;

For trimobile not for hire, the owner has to secure a Registration Permit from the City Government annually to be secured from the Public Safety Office.

All scheduled last day of payment if it falls on Saturday, Sunday or holiday, the succeeding working day shall be considered as the last day for payment / renewal.

SECTION 2. Section 119, Article XXV, of Ordinance No. 93-049, as amended, otherwise known as the Transport and Traffic Code of Naga City, is hereby amended, now to read as follows:

"SECTION 119. - Fees. The City Treasurer or his duly authorized representatives shall collect the following fees in connection with the application / transactions concerning tricycles:

- a) Franchise Fee - Php 300.00 per unit
- b) Annual Supervision Fee - **Php 100.00** per unit
- c) Mayor's Permit Fee - **Php 100.00**
- d) Substitution of Unit - Php 300.00
- e) Legal Research Fee - Php 10.00
- f) Registration Permit Fee
(for private/service unit) - Php 150.00 annually
- g) Sticker Fee - Php 25.00 annually
- h) Police Inspection Fee - **Php 20.00** per unit
- i) Franchising Fee for
Special Routes - Php 150.00 per unit
- j) 25% surcharges on Mayor's Permit and Supervision Fees,
**plus Fourteen Percent (14%) interest per annum, for
late registration unit.**

Any registered trimobile operator who fails to renew his Mayor's Permit on or before the **deadline prescribed under Section 111 and after Sixty (60) calendar days from date of receipt of notice, the operator was not able to renew his/her Mayor's Permit or Franchise**, shall be a ground for cancellation of his Route Measure of Capacity (RMC) slot and franchise to be determined by the Sangguniang Panlungsod.

SECTION 3. Repealing Clause. All ordinances, rules and regulations or provisions thereof which are inconsistent or in conflict with the provisions of this ordinance are hereby repealed, amended and/or modified accordingly.

SECTION 4. Effectivity. This Ordinance shall take effect immediately upon its approval and publication in a newspaper of general circulation.
