AN ORDINANCE PRESCRIBING THE ROUTE OF PUBLIC UTILITY VEHICLES LEADING TO AND FROM THE INTEGRATED TERMINAL FOR SOUTHBOUND, SOUTH SUBURBS AND NORTH SUBURBS (CAMALIGAN, CAMARINES SUR ONLY) LOCATED AT BARANGAY SABANG, SUPPLEMENTING FOR THIS PURPOSE ORDINANCE NO. 2007-041:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - Route Leading to and from the Southbound Terminal. - a) Public Utility Vehicles coming from the North Suburbs, i.e. to and from Camaligan, Camarines Sur, including Trimobiles plying said route, shall pass through Abella St., right turn to J. Hernandez St., right turn to Zamora St., right turn to Gomez St., left turn to Garcia St., then right turn to the road leading to the terminal. In order to avoid traffic congestion along this route, it shall be prohibited to load passengers along the prescribed route.

b) Public Utility Vehicles, except passenger buses going to the Central Bus Terminal, coming from the municipalities Milaor, except the route San Antonio, Milaor to Naga, Minalabac, San Fernando, Pamplona, Pasacao, Libmanan and Cabusao and from the first district of Camarines Sur up to Del Gallego shall turn left to San Miguel St. at Bgy. Mabulo, then right turn to the Mabulo-Sabang By-pass Bridge, then left turn to the terminal. From the terminal these Public Utility Vehicles shall pass through the Mabulo-Sabang by-pass bridge, then left turn to San Miguel St., Bgy. Mabulo, then right turn to the Maharlika Highway leading to their destination.

c) Public Utility Jeeps coming from Gainza, Camarines Sur shall turn left to the Mabulo-Sabang bypass bridge then to the terminal building and vice-versa.

SECTION 2. - Penalty - For violations of the of the routes prescribed under Section 1 hereof shall be penalized as follows:

1st Offense - a fine of One Thousand Five Hundred (P1,500.00) pesos;

2nd Offense - a fine of Two Thousand Five Hundred (2,500.00) pesos;

3rd and subsequent Offenses - a fine of Five Thousand (5,000.00) pesos, plus and imprisonment of not less than 60 days, nor more than One (1) year at the discretion of the Court, without prejudice for the recommendation to the Land Transportation Office for the revocation of the Driver's License and/or to the LTFRB for the revocation of Certificate of Public Convenience.

SECTION 3. - Prohibited Acts. - In order to avoid traffic congestion along the junction of San Miguel St., Mabulo and the adjacent portion of the Maharlika highway, waiting of passengers in this portion of Bgy. Mabulo is hereby prohibited, except unloading of passenger.

SECTION 4. - Repealing Clause - The provisions of existing ordinances including the Ordinance prescribing for Administrative Fines which are inconsistent with the provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. - Effectivity. - This ordinance shall take effect upon its approval and Fifteen (15) days after publication in a newspaper of local circulation.
