AN ORDINANCE AMENDING ORDINANCE NO. 2005-080, ENTITLED "AN ORDINANCE MANDATING THE NUMBERING OF RESIDENTIAL, COMMERCIAL AND INDUSTRIAL BUILDINGS IN THE CITY OF NAGA"-

Be it ordained by the Sangguniang Panlungsod of the City of Naga in Session assembled, that:

SECTION 1. Section 4 of Ordinance No. 2005-080 is hereby amended by adding as paragraph e the definition of the term "bar code" as follows:

e. Bar code - is an optical machinereadable representation of data by varying the widths and spacings of parallel lines, which shows data about the object to which it attaches, in this particular case, the detailed information of the house, commercial, and industrial buildings, including but not limited to the occupants thereof, thereby providing fast, efficient and accurate data for easy monitoring and identification.

SECTION 2. Section 5 paragraph b and paragraph d, item no. 8 of Ordinance No. 2005-080 are likewise amended, now to read as follows:

Section 5. - Mechanics. - a) All residential, commercial and other buildings in the City of Naga shall be assigned a permanent number (according to locations such as street and zone of each barangay, numbered) consecutively from number 1 up to the last number of a house/building (in a particular street, provided that, in cases of duly approved subdivisions who has pre-assigned lot and block numbers, the same shall be followed in the numbering of houses/building therein) reflecting the street and the Barangay wherein such subdivision is located. Page-two-

b) The plate to be used shall be four inches in width and eight inches in length. It shall contain the following information: 1. the street name at the top of the plate; 2. Zone number and the name of the Barangay; 3. the number which shall be 2 inches in height; 4. In cases of subdivisions, the name of the subdivision shall be placed below the street name; and 5. the word "NAGA CITY" in bold letters, placed at the bottom of the plate, and a Bar Code on the lower left portion.

c) The number plate shall be color coded by zone which shall be uniform in all barangay, e.g. Zone I - yellow; Zone II - Blue, Zone III - Green; etc.

d) The numbering of houses/commercial/industrial building shall be as follows:

- 1. The numbering shall be by street;
- 2. The numbering shall be consecutive from one end of the street to the opposite end;
- 3. One side of the street shall be assigned odd number, while on the other side an even number, except those located in areas where there are no existing buildings, or it is impractical to follow the odd and even scheme provided herein;
- 4. The numbers should be set on a background of contrasting color, e.g. black on white or red on blue;
- 5. In cases of subdivisions, vacant lots shall be included in the numbering according to the subdivision plan. Once a house/building is constructed therein, it will be assigned its house number;
- 6. In cases of apartment buildings or compound with more than one door or house/building, each door or house/building shall be assigned an alpha numeric number according to location, e.g. 7-A, 7-B and son on;
- to location, e.g. 7-A, 7-B and son on; 7. The plate shall be installed in a location visible from the road;
- 8. The number plate may be placed either on top or lower portion of mailboxes, but in no case shall it be lower than five (5) feet from the ground for purposes of visibility.

e) The numbering of houses/buildings shall commence either from the eastern or northern part of the street as reference.

ORDINANCE NO. 2011-057 Series 2 0 1 1 Page-three-The house or building plates f) shall be preceded by the following capital letter: 1. R for residential houses 2. C for commercial buildings 3. I for institutional buildings, and 4. G for government buildings g) Vacant lots shall be allocated their respective number plate depending on its location in the barangay. SECTION 3. - Section 13, par. b of Ordinance No. 2005-080 is hereby repealed.

 $\ensuremath{\text{SECTION}}$ 4. - This ordinance shall take effect upon its approval.
