

**ORDINANCE NO. 2013-024**

**AN ORDINANCE SETTING RENTAL RULE FOR THE USE OF AVAILABLE  
PARKING SPACES WITHIN THE PREMISES OF THE JESSE M. ROBREDO  
COLISEUM:-**

On Joint and Collective Motion

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

**SECTION 1. Parking Fee** – No parking or rental fee shall be levied and collected for the use of any available parking spaces within the premises of the Jesse M. Robredo Coliseum on those conducting offices and in connection with the events or activities being permitted thereat consistent with the intents and purposes for which the Coliseum was constructed.

However, for reasons other than said enumeration, being imposed for collection and payment is the sum of P40.00 per vehicle for the first two (2) hours plus the sum of P10.00 per hour thereafter. Provided, that such usage shall not be allowed beyond 6:00 o'clock evening of any given day.

**SECTION 2. Prohibited Acts.** – (a) It is unlawful for any private individual or entity to collect parking fee for the use of any parking space within the premises of the Jesse M. Robredo Coliseum. (b) It is likewise unlawful for any operator or driver of any public utility vehicle to park at or utilize any public road or private property within the Central Business District II for the purpose of using the same as a terminal or for soliciting passengers thereat, except only at the place designated by the city government.

**SECTION 3. Penalties.** For committing any of the above prohibited acts, the offender shall be penalized as follows:

- (a) For the first offense – a fine of One Thousand Five Hundred Pesos (P1,500.00) or an imprisonment of thirty (30) days, or both at the discretion of the Court;
- (b) For the second offense – a fine of Three Thousand Pesos (P3,000.00) or an imprisonment of sixty (60) days, or both at the discretion of the Court; and
- (c) For the third and succeeding offenses – a fine of Five Thousand Pesos (P5,000.00) or an imprisonment of ninety (90) days, or both at the discretion of the Court.

Provided, that each act shall be treated and considered distinct and separate from the other.

**SECTION 4. Effectivity.** Section 1 of this Ordinance shall take effect immediately upon its approval while the rest of the provisions after fifteen days from its publication.
