## ORDINANCE NO. 2014-007

# AN ORDINANCE NAMING THE CENTRAL BUS TERMINAL IN TRIANGULO, THIS CITY, AS BICOL CENTRAL STATION:-

On joint and collective motion

#### Explanatory Note

WHEREAS, Ordinance No. 1993-041 mandated the establishment of a central bus terminal in Naga City which shall serve as the sole loading and unloading facility of all public utility buses coming from, going to or passing through the City of Naga to or from any point of destination or origin;

WHEREAS, pursuant to said ordinance, the city government constructed a central terminal for PUBs in Central Business District II, Triangulo, Naga City;

WHEREAS, the aforementioned central terminal for PUBs has, since it became operational in 1999, served as a vital transportation hub and has become one of the most vital public facilities and economic enterprises of the city, promoting Naga's stature as one of the most competitive cities in the country;

WHEREAS, being the primary hub of tourist and business buses, the said terminal is the first edifice that travellers and businessmen see in our city and gives the first impression of the city on them, making it one of the crucial elements in marketing a good image for Naga;

WHEREAS, Ordinance No. 1993-041 did not provide any specific name for the said central bus terminal;

WHEREAS, naming the said edifice as Bicol Central Station would be most appropriate as it is in consonance with Naga City's image as the Heart of Bicol;

WHEREAS, said name likewise denotes the city's desire to invigorate the area by upgrading the facilities thereat

and introducing new improvements that will expand trade and commercial transactions therein;

- **BE IT ORDAINED**, therefore, by the Sangguniang Panlungsod of the City of Naga, in session duly assembled, that:
- **SECTION 1. TITLE.-**This ordinance shall be known as the "Bicol Central Station Ordinance".
- SECTION 2.-THE BICOL CENTRAL STATION.- The terminal for buses that is situated in Central Business District (CBD) II, then referred to as the Central Bus Terminal, is hereby named as the Bicol Central Station.
- All ordinances, rules and regulations and other pertinent documents referring to the said terminal shall, henceforth, mean to denote to the Bicol Central Station.
- **SECTION 3. REPEALING CLAUSE.-** All previous ordinances, issuances and regulations or part/s thereof which are inconsistent with this ordinance are hereby repealed, amended or modified accordingly.
- **SECTION 4. EFFECTIVITY CLAUSE.-** This ordinance shall take effect immediately upon its approval.
