AN ORDINANCE REVISING ORDINANCE NO. 261, S. 1964 AND ORDINANCE NO 92-060, PROHIBITING TUMULTS, DRUNKENNESS OR INTOXICATION, OR BEHAVIOR IN A DRUNKEN, BOISTEROUS, RUDE, OR INDECENT MANNER IN ANY PUBLIC PLACE OR PLACE OPEN TO PUBLIC VIEW, DISORDERLY GATHERING IN PUBLIC PLACES, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF:-

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1:- Definition of Terms: As used in this ordinance, the following terms shall mean:

- a) **Tumults** - can refer to a violent and noisy commotion or disturbance of a crowd or a general outbreak or disorder, riot.
- b) **Drunkenness**- is a consequence of drinking intoxicating liquors to such an extent as to alter the normal condition of an individual and significantly reduce his capacity for rational action and conduct, or as that state or condition which inevitably follows from taking excessive quantities of an intoxicant to such a degree as to deprive him or her of reasonable self-control.
- c) **Intoxication** - the condition of being drunk as the result of drinking alcoholic beverages and/or use of narcotics.
- d) **Boisterous** - Loud or noisy and lively or unrestrained.
- e) **Rude or Rudeness** is a display of disrespect by not complying with the social norms or etiquette of a group or culture. These norms have been established as the essential boundaries of normally accepted behavior. To be unable or unwilling to align one's behavior with these norms known to the general population of what is socially acceptable is to be rude and are enforced as though they were a sort of social law, with social repercussions or rewards for violators or advocates.
- f) **Indecent Manner** - offensive to accepted standards of decency or modesty; lewd or vulgar.

SECTION 2. -Prohibited Acts. A) It shall be unlawful for any person or persons to create tumults or disturbances in places where there are public gathering, or shall form disorderly gathering or congregations in public streets, public alleys, plazas and other public places creating or tending to create disturbance to the peace and tranquility of the people thereat;

b) It shall be unlawful for any person or persons to drink wine, whiskey, brandy, rum, beer, or any intoxicating liquor in public streets, plazas, public alley, public schools, churches, and in public market, except in those cases provided for and authorized by law and ordinance; or walk in a state of drunkenness or intoxication, or behavior in a drunken, boisterous, rude, or indecent manner in any public street, public alleys, plazas, and other public places, or place open for public view, or in any place or premises in the annoyance of other person or tending to offend against decency or good custom by any scandalous conduct; or shall exhibit indecent or immoral acts or scenes.

SECTION 3:- Penalty. Any person or persons violating any of the provisions of this ordinance, shall pay the fine of Three Thousand (P3,000.00) Pesos

On the second offense and upon conviction, the penalty shall be a fine of Four thousand (P4,000.00) Pesos and/or imprisonment of not exceeding Six (6) months, at the discretion of the court;

Upon subsequent conviction, the penalty shall be a fine of Five Thousand (P5,000.00) and imprisonment of not exceeding 1 year at the discretion of the court;

SECTION 4:- Repealing Clause. – The provisions of Ordinance No. 261, s. 1964 and Ordinance No. 92-060 are hereby repealed.

SECTION 5. This Ordinance shall take effect after publication in a newspaper of local circulation.
