ORDINANCE REVERTING THE AMOUNT OF FOUR MILLION FIVE HUNDRED EIGHTY THOUSAND PESOS (P4,580,000.00) FROM SCHOLARSHIP/GRANTS EXPENSES OF THE EDUCATION, SPORTS AND SCHOLARSHIP OFFICE (ESSO) TO UNAPPROPRIATED BALANCE, AND APPROPRIATING THE SAME TO ELECTRICITY EXPENSES OF THE CITY MAYOR'S OFFICE TO AUGMENT THE SAID ACCOUNT TO A LEVEL SUFFICIENT TO COVER THE ANTICIPATED BILLINGS OF CASURECO II FOR DECEMBER 2016:-

On joint and collective motion

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - The Amount Of Four Million Five Hundred Eighty Thousand Pesos (P4,580,000.00) from Scholarship/Grants Expenses of the Education, Sports and Scholarship Office (ESSO) is hereby reverted to unappropriated balance, and appropriating the same to electricity expenses of the City Mayor's Office to augment the said account to a level sufficient to cover the anticipated billings of CASURECO II for December 2016;
