AN ORDINANCE REVERTING THE AMOUNT OF THREE HUNDRED NINETY THOUSAND PESOS (P390,000.00) FROM BUB COUNTERPART UNDER SPECIAL PURPOSE APPROPRIATION (SPA) TO SUBSIDY TO NATIONAL GOVERNMENT AGENCIES-DEPARTMENT OF EDUCATION UNDER SPECIAL PURPOSE APPROPRIATION (SPA), TO COVER THE GRANT OF ADDITIONAL ALLOWANCE OF ONE THOUSAND PESOS (P1,000.00) TO EACH PERSONNEL OF THE DEPARTMENT OF EDUCATION PRESENTLY RECEIVING MONTHLY ALLOWANCE FROM THE CITY GOVERNMENT:-

On joint and collective motion

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - The amount of Three Hundred Ninety Thousand Pesos (P390,000.00) from BUB Counterpart under Special Purpose Appropriation (SPA) is hereby reverted to Subsidy to National Government Agencies-Department of Education under Special Purpose Appropriation (SPA), to cover the grant of additional allowance of One Thousand Pesos (P1,000.00) to each personnel of the Department of Education presently receiving monthly allowance from the city government;

SECTION 2. - This ordinance shall take effect upon its approval.
