AN ORDINANCE GRANTING ADDITIONAL ALLOWANCE OF ONE THOUSAND PESOS (P1,000.00) TO EACH DEPARTMENT OF EDUCATION PERSONNEL PRESENTLY RECEIVING MONTHLY ALLOWANCE FROM THE CITY GOVERNMENT OR A TOTAL OF ONE MILLION FIVE HUNDRED THIRTY SIX THOUSAND PESOS (P1,536,000.00), CHARGEABLE AGAINST THE SUBSIDY TO NATIONAL GOVERNMENT AGENCIES-DEPARTMENT OF EDUCATION UNDER SPECIAL PURPOSE APPROPRIATION (SPA):-

On joint and collective motion

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - Each Department of Education personnel presently receiving monthly allowance from the city government is hereby granted additional allowance of One Thousand Pesos (P1,000.00) or a total of One Million Five Hundred Thirty Six Thousand Pesos (P1,536,000.00), chargeable against the subsidy to National Government Agencies-Department of Education under Special Purpose Appropriation (SPA);

SECTION 2. - This ordinance shall take effect upon its approval.
