AN ORDINANCE REVERTING TO UNAPPROPRIATED BALANCE THE AMOUNT OF EIGHT HUNDRED SIXTY SIX THOUSAND SEVEN HUNDRED PESOS (P866,700.00) FROM BUB COUNTERPART FUND UNDER SPECIAL PURPOSE APPROPRIATION (SPA), AND APPROPRIATING THE SAME TO BARANGAY SUPPORT FUND UNDER SPA TO COVER THE GRANT OF BARANGAY PERFORMANCE INCENTIVE TO THE CITY'S BARANGAY OFFICIALS AT THREE THOUSAND PESOS (P3,000.00) EACH FOR PUNONG BARANGAYS, BARANGAY KAGAWADS, BARANGAY TREASURERS AND BARANGAY RECORD KEEPERS, AS WELL TWO THOUSAND ONE HUNDRED PESOS (P2,100.00) EACH FOR BARANGAY SECRETARIES:-

On joint and collective motion

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - The amount of Eight Hundred Sixty Six Thousand Seven Hundred Pesos (P866,700.00) From BUB Counterpart Fund Under Special purpose appropriation (SPA) is hereby reverted to unappropriated balance, and appropriating the same to Barangay Support Fund under SPA to cover the grant of Barangay Performance Incentive to the city's barangay officials at Three Thousand Pesos (P3,000.00) each for punong barangays, barangay kagawads, barangay treasurers and barangay record keepers, as well Two Thousand One Hundred Pesos (P2,100.00) each for barangay secretaries;

SECTION 2. - This ordinance shall take effect upon its approval.
